The City of Southfield is seeking qualified candidates for the following position:

JOB CLASSIFICATION: Building Inspector I

This is an intermediate position where the applicant will perform unsupervised inspections and plan reviews, gains additional knowledge in all disciplines with the ability for advancement within the department.

JOB DUTIES

- Performs basic unsupervised field inspections related to residential and commercial construction in conformance with the Michigan Building Codes.
- Review building, remodeling, demolition plans and specifications to ensure compliance with applicable laws, zoning ordinances, and building codes and issue appropriate permits.
- Advise contractors, builders, residents and the public regarding building codes, permits, zoning requirements, policies and procedures in person and by phone.
- Coordinate with City Departments (Planning, Engineering, Water, Assessing and Legal), contractors, architects, engineers and others to expedite the plan review process.
- Maintain accurate records; Perform various mathematical calculations to determine code compliance.
- Preparation of documents required for residential variances to the Zoning Board of Appeals.
- Research historical records and information related to property records and permits.
- Ability to learn dedicated department software (BS&A)
- Other related duties as assigned.

JOB REQUIREMENTS:

- High school graduate or equivalent;
- Registered as a Building Inspector and Plan Reviewer with the State of Michigan under 407.
- 1 year experience as a Building Inspector/Plan Examiner in residential and/or commercial construction.
- Must possess a working knowledge of Michigan Building Codes and related standards and the ability to apply this knowledge in the field and while conducting plan reviews.
- Effective written and oral communication skills.
- Valid Michigan driver's license and a good driving record as determined by the City's Driving Standards.

The selection process will include a review of qualifications, driving record and criminal history check, and an oral board interview. Each step of the process must be passed before the applicant will be moved to the next step. Applicants will be invited to further participate in the selection process based on the nature and extent of their related experience.

This is a "continuous" recruitment. Applications will be accepted until there are sufficient applicants to meet the City's recruitment needs. As such, interested persons should make application promptly.
