PROPOSAL SECTION SOUTHFIELD PUBLIC SCHOOLS RENEWAL OF OPERATING MILLAGE

This proposal would renew expiring authority of the Southfield Public Schools to levy mills for general operating purposes. Under this proposal, due to current enrollment projections and statutory exemptions, principal residences, qualified agricultural property, industrial personal property and other property to the extent not otherwise exempt for this purpose under State law would be partially exempt from the 18 mill levy, and the School District would continue to be eligible to receive full per pupil revenue permitted by law.

As a renewal of authority which expires with the 2014 levy, shall the limitation on the taxes which may be levied upon taxable property in the Southfield Public Schools, Oakland County, Michigan, be increased by

18.00 mills (\$18.00 per \$1,000 of taxable value) for six years, the years 2015 to 2020, inclusive, to provide funds for operating expenses of the District? Of the 18.00 mills, no more than 17.6345 mills (\$17.6345 per \$1,000 of taxable value) may be levied on principal residences, qualified agricultural property and industrial personal property. This authorization would allow the District to raise through levy an estimated \$41 million in operating revenue in 2015.
