Introduction

CDBG funds are the primary source of funding. Revolving Loan funds (program income) will provide additional funds for the Southfield Home Improvement Program. In addition, the city refers residents to other agencies and supports grant application requests by other service providers. The city is considering pilot programs with the use of non-federal funds to improve housing stock and prevent neighborhood deterioration.

The city received a special allocation from the enactment of the CARES Act. The activities and funding are incorporated into a substantial

amendment to the PY2019 Annual Action Plan.

The Neighborhood Stabilization Program (NSP) in corporation with Habitat for Humanity is constructing 4 new single-family homes for low income families. Completion is anticipated in the spring of 2021. The Southfield Neighborhood Revitalization Initiative (SNRI) also in corporation with Habitat for Humanity homes are also rehabilitating homes and building new residential units. In the near future the city will conduct a housing study to look at the market conditions, needs and possibilities.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

Priority is given to maintaining the existing housing stock, its value but also its sustainability. Housing rehabilitation also helps the homeowner remain living in a safe and affordable owner-occupied dwelling. Funding priority is also given to residents in need of immediate public services like funds for utilities, rent and medical needs and those that are homeless or victims of domestic violence. The recreational and educational needs of our low-income youth are also addressed with CDBG funds. Obstacles remain in the amount of funds available for each project, the cost and availability of building materials, and additional needs and concerns due to the Corona Virus Pandemic. As a result of the 7% reduction of entitlement funds this fiscal year, two prior projects, Senior Transportation and Code Enforcement were not funded.

The CDBG program is the primary source of funding for Consolidated Plan activities. The goal is to maintain existing programs. Secondly to network with other service providers, and finally to solicit funds from other grant sources.

Actions planned to address obstacles to meeting underserved needs

The city will look at other funding opportunities and organizations to address the many needs

Actions planned to foster and maintain affordable housing

The City has developed several programs to foster and maintain affordable housing. This includes a tax enterprise zone, which encourages property owners to invest in their property with the use of tax incentives. Secondly, the Southfield Neighborhood Revitalization Initiative Program was developed, to purchase tax foreclosed houses, rehabilitate them and resell them in a partnership with Habitat for Humanity.

Actions planned to reduce lead-based paint hazards

The City of Southfield continues to test for lead-based paint hazards for households participating in the Southfield Home Improvement Program and the Oakland County Home Program. The Southfield Home Improvement Program will correct violations with lead safe work practices. Other inquiries will be referred to websites the educate on the "dangers of lead paint".

Actions planned to reduce the number of poverty-level families

The Smart Zone Program proposes to assist lower income residents to improve job skills and to seek higher paying jobs. This combined with Michigan Works Programs will be important in directing residents to employment opportunities. It is a partnership with the State of Michigan, Oakland County, the City of Southfield in cooperation with the Southfield Public Schools.

Actions planned to develop institutional structure

The City has reorganized the city structure and departments to provide better service delivery systems.

Actions planned to enhance coordination between public and private housing and social service agencies

The City will meet with service agencies and may partner with other services groups to leverage

dollars. Recently, the City formed a partnership with Habitat for Humanity called the 'Neighborhood Revitalization Initiative'. This program obtained 50 taxed foreclosed properties, rehabilitated the and resold properties to owner occupied homebuyers. No federal funds were used for this program. Also on May 26, 2020 the Southfield Growth Corporation authorized the sale of 4 properties to Habitat for Humanity, for the construction of new, affordable, single-family housing units.
