


Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers

Officers were dispatched to the 25000 Block of Evergreen (Gas Station) reference a report of a man down claiming to have been shot. Upon arrival, it was determined that the victim had not been shot but had been stabbed in the upper torso. The victim was able to provide a description of the suspect. B/M wearing a tan jacket and was riding a bicycle N/B on Evergreen Rd. Officers located the suspect attaching his bicycle to a bus at the bus stop at Goldwin & Evergreen Rd. As Officers pulled up the suspect immediately dropped to the ground and surrendered. The suspect was taken into custody and the knife was recovered in a bag attached to his bike. The victim was taken to the hospital where he was treated and it was reported he was in stable condition. The suspect was transported to the Southfield Jail where he was lodged.

The driver was in violation of time and there were four passengers under the age of 21.

When the occupants where asked if there were any other guns in the car the driver kicked off his shoes and Officers located a second gun in one of the drivers shoes.

The driver and passenger that made admissions that the gun was his were taken into custody for CCW Motor Vehicle.
