# Investment Performance Report

Mr. Kuhn began with a thank you from AndCo's President/CEO, Mike Welker. The company had grown to 87 employees with a strong focus on research and compliance. He went on to present the 4<sup>th</sup> Quarter Performance Report reviewing the capital markets, highlighting the strong returns from the international and domestic equity markets, and the more modest gains from bonds. He reviewed the Fund's asset allocation vs. targets, financial transactions, and performance; the Fund was up 3.8% for the quarter and 17.9% for the year. He also covered the performance of the individual managers, including the strong results from the active small/mid cap managers and the exceptional returns from the overall fixed income allocation; this was achieved in spite of weak results from Templeton.

The Board questioned the *Other Expense* column on the Financial Reconciliation page, particularly for the Bloomfield accounts. Mr. Kuhn indicated that he would provide more detail on these expenses.

Updated market values (\$117 MM) were distributed and noted was the prudent timing of the rebalancing in January. No action was recommended.
