## INSTRUCTIONS TO THE DEFENDANT

(Revised January 2024)

Your sentence includes the opportunity for Community Service. This means that:

- 1. It is **YOUR RESPONSIBILITY** to locate a non-profit organization to volunteer at.
- 2. If you choose a non-profit organization that is not listed in this booklet, it is **YOUR RESPONSIBILITY WITHIN 2 WEEKS** of starting Community Service to get <u>prior approval</u> from your probation officer for the particular job you wish to do. (The agency must include the 501C3 tax identification number).
- 3. It is **YOUR JOB** to perform the work.
- 4. **YOU MUST** have written verification of completed hours sent to the Probation Department along with the completed 46<sup>th</sup> District Court Probation Service Log (next page).

Requirements for Written Verification: Verification <u>must</u> be on the non-profit organization's letterhead and signed and dated by an

authorized agent of the organization.

Requirements for Service Log: Service Log <u>must</u> be completed with all information and hours totaled.

**IF YOU ARE ON A NON-REPORTING PROBATION:** (reporting to kiosk) You are responsible for providing the Written Verification and the Service Log with the above requirements to your Probation Officer.

In the past, there have been defendants who have been hired by the community service agency because their work was done very well. Others received jobs based on the letters of reference they received from the community service agency. Unfortunately, there are also those who somehow prefer jail. It's **YOUR** choice!
