EYES ON SOUTHFIELD

very resident and business owner has a vested interest in maintaining property values by keeping Southfield clean and attractive. The City of Southfield is committed to working with residents and businesses to keep Southfield

beautiful. With an increased focus on curb appeal, the Southfield Code Compliance Department will respond to most complaints within a 24- to 48-hour time period. Code Compliance Officers canvass the City seven days-a-week to monitor the condition of Southfield homes and neighborhoods. In addition, the City relies on the "eyes and ears" of the entire community to report any obvious or extreme code violations. In an effort to maintain curb appeal, the City has initiated the "Eyes on Southfield" program to enable residents to notify the City with ease when a code or blight issue is observed. Residents may simply call (248) 796-EYES (3937) 24 hours-a-day, seven days-a-week to report code issues or violations. When a violation exists, code officers will inform the resident or business of the issue and educate them



how to correct it. If another violation occurs at the same property, the home or business owner will be issued a civil infraction and must appear in court.

Residents are reminded of the following community appearance standards:

- Weeds and grass must be cut on a regular basis. Lawn grass should not exceed eight-inches in length.
- Trash is not to be placed at the curb before 4 p.m. the evening prior to collection. Refuse is limited to 60 pounds of material and must be placed in plastic bags or waste containers no larger than 32-gallon capacity. All containers must be removed no later than noon the day following trash collection.
- Yard waste must be placed in approved paper yard waste bags or in a rigid container clearly marked 'yard waste.'
 Yard waste in plastic bags will not be accepted. Yard waste includes leaves, grass clippings, branches, brush and other organic material only.
- Unlicensed or inoperable vehicles may not be parked outside of a garage. The repair of vehicles is not permitted on residential property.
- Outside storage is not permitted, except in industrial zones. Outside storage constitutes anything placed outside that is not in immediate use. Outside storage of recreational vehicles, snowmobiles, boats, travel trailers and mobile homes exceeding 20-feet in length is not permitted and must be stored offsite. Recreational vehicles, boats and travel trailers less than 20-feet in length may be stored in the backyard only.
- Buildings must be maintained according to City code regulations, including no peeling or weathered paint, cracked or broken glass, fallen gutters, litter or debris, or other maintenance issues.

Let's each do our part to keep Southfield clean and attractive by maintaining our homes and neighborhoods. Every Southfield resident can do their part to keep our community clean and attractive. 
City of Southfield wins MEDA award for best Web site

City of Southfield earns strong bond rating

The City of Southfield's AA+ bond rating was reaffirmed on July 20 by Standard & Poor's, one of the nation's major bond rating agencies, placing

the City in the top three percent of all rated governmental agencies in Michigan. Standard & Poor's rating is reflective of the City's ability to show adherence to its five-year budget stabilization plan as well as the city's stable, steadily increasing, diversified local economy; above-average wealth and income levels; and moderate to low debt burden.

"Having a strong credit score is an impressive accomplishment in these tough economic times for Michigan cities." commented Southfield City Council President Sylvia Jordan. "This saves the taxpayers money when the City needs to sell bonds to fund major capital projects like roads, bridges, and water/sewer system improvements. A strong credit rating results in lower interest costs and better terms for any bond issues. The AA+ rating is also a sign of financial stability with good management systems in place and a strong set of fiscal policies established by City Council. This is teamwork in action. All elected officials and the City's management staff are united in their commitment to maintaining the financial integrity and strong financial position of the City. There is a longrange future vision at work here."

The City's financial position has been

hampered in recent years by a steady AA+ decline in state shared revenues, the acco second largest single revenue component next to property taxes. The The

total projected in the fiscal year 2007-08 budget of \$6,776,303 is \$3,000,013, or 31 percent, less than the high-point total of \$9,776,316 in fiscal year 2001-02. The City has been able to work toward returning to structural balance, however, by adopting and adhering to a five-year budget stabilization plan, attrition of some city positions, and new employee contracts.

Treasurer City Irv Lowenberg commented that the achievement of this excellent bond rating is primarily due to the City's "Five Year Fund Balance Stabilization Plan" established in the 2004-05 fiscal year. "We are currently in the fourth year of the plan and are on target to its objective which is to wean the City off of the use of fund balance reserves for day-to-day operations," continued Lowenberg. "Given the challenges of the current Michigan economy, achieving a AA+ bond rating is a major accomplishment."

The City's commitment to stay on course with the five-year plan is reflected in the fiscal year 2007-08 general fund budget increase of \$995,951, or just 1.5 percent. The July 2007 Municipal Cost Index (MCI), the Consumer Price Index (CPI) for city operations developed by the American City and County trade publication for municipalities, indicates increase of 3.6 percent nationally.

"This strong rating is extremely important to the City's business reputation and benefits all taxpayers of the City," stated Joan Seymour, chair of the Council Finance Committee. "Major capital projects are necessary to keep the City first class and bond issues are necessary to fund such projects. A strong bond rating for the City, much like strong credit score to an individual, enables us to save money by getting lower interest rates on the bonds. The AA+ bond rating confirms Southfield's ability to effectively manage financial resources, making it an attractive destination for new business development, redevelopment and future fiscal growth. It is critical that we stay on course to the five-year plan, which includes holding-the-line and strictly adhering to our 2007-08 budget plan."





YARD WASTE COLLECTION ENDS NOVEMBER 30

As autumn approaches and the leaves begin to fall, residents are reminded that leaves and other vard waste are collected on their regular weekly garbage collection day through Friday, November 30, 2007. Yard waste includes leaves, grass clippings, branches, brush and other organic material only. Yard waste must be placed in approved paper yard waste bags or in a rigid container clearly marked 'yard waste.' Yard waste in plastic bags will not be accepted. Branches and brush refuse must be placed with the cut ends towards the curb on the regular trash collection day.

Trash is not to be placed at the curb before 4 p.m. the evening prior to collection. Refuse is limited to 60 pounds of material. Refuse must be placed in plastic bags or waste containers no larger than 32-gallon capacity. All containers must be removed no later than noon the day following trash collection.

Municipal Election November 6, 2007

Preparations are underway in the City Clerk's Office for the Municipal General Election scheduled to be held on Tuesday, November 6, 2007. Southfield voters will go to the polls to elect the following offices:

City Council (4 seats)

The November 6, 2007 Election ballot may also include several Charter proposals. For candidate and additional ballot information contact the City Clerk's Office or visit the Southfield Web site, www.cityofsouthfield.com. and click on the Government tab, City Clerk's Office for more information.

Close of Registration

Michigan election law states that you must be registered to vote 30 days in advance of an election.

The Close of Registration deadline for the November General Election is October 9, 2007.

If you are not currently registered to vote in Southfield, please visit the City Clerk's Office, or any Secretary of State Branch office, or visit the City Web site at www.cityofsouthfield.com. If you are physically unable to appear in person, please call City Clerk Nancy L. M. Banks at (248) 796-5150, to make arrangements for a member of the City Clerk's Office to register you at home.

Absent Voter Applications

Michigan law requires that registered voters wishing to receive an absent voter ballot must complete an Absent Voter Application for each election for which an absentee ballot is needed. All registered voters age 60 vears and over, and disabled residents who have requested same, were mailed the Absent Voter Application in September. The Application must be returned to the City Clerk's Office, completed and signed, before an Absent Voter Ballot can be mailed to the voter. If you need an Absent Voters Ballot for the 2007 Election. contact the City Clerk's Office at (248) 796-5150, or visit the City Web site at www.cityofsouthfield.com.

Attention College Students

State law requires that the address on your driver's license match the

address on your voter registration record. Any address change submitted for your driver's license will automatically change your voter registration record. This particularly important information for college students who often change their driver's license to reflect their college address. College students who change their driver's license to their college address will be required to vote in their college community. For more information, contact the City Clerk's Office.

Precinct Information

Do you know your voting precinct number and polling location. All registered voters in the City of Southfield received new Voter Identification Cards in February 2005. Any registered voter who has not received a new Voter ID Card should contact the City Clerk's Office at (248) 796-5150.

Please remember to bring your Voter ID Card or Driver's License with you on Election Day.

Passports

If you are planning to travel abroad, or just take a day trip to Canada, you may want to apply for a U.S. Passport



to make your traveling easier and more efficient. On January 23, 2007, all U.S. citizens traveling by air to or from Canada, Mexico, Central and South America, the Caribbean and Bermuda will require a U.S. Passport! On December 31, 2007, the requirement for a passport will be extended to include all sea and land border crossings as well.

The Southfield City Clerk's Office is an official Passport Acceptance Agency designated by the U.S. Department of State to accept and process passport applications. United States citizens interested in applying for a U.S. Passport must submit proof of citizenship, such as a certified birth certificate, a previous U.S. Passport. Naturalization Certificate or Report of Birth Abroad; plus identification such valid Driver's License. Naturalization/Citizenship Certificate, or official Military Identification Card; plus two recent 2" x 2" photos on white or off-white background, and the appropriate application fees.

Application fees are \$67 for an adult 16 years of age or older; \$52 for applicants 15 years of age and younger, payable by check or money order to the U.S. Department of State. A \$30 cash execution fee is also required for each application. Routine applications take 10-12 weeks to process; expedited applications are processed within 2-3 weeks for an additional \$60.

Winter Weather Reminders

Taking preventive action is your best defense against having to deal with extreme cold-weather conditions. By preparing your home and car in advance for winter emergencies, and by observing safety precautions during times of extremely cold weather, you can reduce the risk of weather-related injuries.

Preparing your home for extreme winter cold

- 1. If you plan to use a fireplace or wood stove for emergency heating, have your chimney or flue inspected each year.
- 2. Insulate any water lines that run along exterior walls so your water supply will be less likely to freeze.
- **3.** Have a generous supply of water and dry food available in case of long power outages.

Preparing your car for severe winter weather

- 1. Have the radiator system serviced or check the antifreeze yourself with an antifreeze tester and add some if necessary.
- 2. Replace any worn tires and check the air pressure of your tires.
- **3.** Make sure windshield wiper fluid is full and add a wintertime mixture.
- 4. Prevent gas lines from freezing by monitoring fuel level and maintaining at least a half tank of gas at all times.

Safety guidelines for space heaters

- 1. Do not place heater within three feet of anything that may catch on fire, such as drapes, clothing, furniture, etc.
- 2. Never cover the heater.
- **3.** Avoid using extension cords to plug in a heater.
- 4. Install carbon monoxide (CO) detectors.
- 5. Follow all manufacturer's warnings.

Fire Hydrant Ordinance

By City ordinance, all fire hydrants must be visible and accessible for fire service use. Please do not block or pile snow over hydrants and advise any maintenance or snow removal service of the importance of clear, accessible hydrants.

It is also important to maintain proper heat temperatures in stairwells with sprinklers or hose connections to keep water lines from freezing.

Snow Removal Guidelines

Simple measures can be taken to ensure the safety of pedestrians and drivers during the winter months. Southfield City ordinance requires residents and businesses to clear their sidewalks in a timely fashion for pedestrian safety and to expedite mail delivery.

To minimize snow buildup in front of driveways, residents should remember to shovel snow from left to right as they face the street. Residents should also remember to remove all vehicles from the street whenever there is a significant snowfall to aid in plowing. Fire hydrants and catch basins should also be kept as clear as possible.

If your annual income does not exceed \$40,000 and you own and reside in your home, you may be entitled to a property tax deferment. You must be at least 62 years of age or, if under 62 years, retired because of a disability and unable to work. Property taxes may be deferred under certain conditions. 
"Tuesdays with the Treasurer"

Animal rescue league re-opens shelter in Southfield

The Almost Home Animal Rescue League is a non-profit 501(c)(3) organization dedicated to finding loving homes for homeless animals. Almost Home is made up of a group of dedicated volunteers who strive to find homeless cats and dogs good homes. The League is strongly against euthanasia of adoptable animals and continuously works to match friendly pets with good families.

Almost Home rescues homeless animals (many of which would otherwise be euthanized) and properly cares for them until they are adopted. Since 2001, the group has been helping animals without the benefit of an actual dedicated shelter. Last year, the City of Southfield partnered with Almost Home to allow the group to utilize the City's former animal shelter on Clara Lane in return for all Southfield strays and

abandoned animals to be cared for and sheltered at the facility. Many of the animals at the shelter have been brought in by the police after being found wandering without an ID tag. Residents are reminded that the City of Southfield requires all dogs (and cats) to be licensed and to wear collars with ID tags. Failure to do so could result in the owner being ticketed, and if the owner is not located within three days, the City may transfer that animal and the owner could lose all rights to their pet. The issuance of a license requires proof of vaccination for rabies, which is necessary for the health of the pet and for the protection of the community.

While the City provides the facility, Almost Home is responsible for all operating expenses at the shelter, including food and veterinarian costs. Tax deductible donations are



always accepted and much needed to defray expenses.

Almost Home is staffed entirely by a team of dedicated volunteers. The organization is currently looking for other responsible and caring individuals to assist with clean up, walking dogs, helping at adoptions and fundraisers, painting and paperwork. To date, the Almost Home Animal Rescue League has rescued almost 2000 dogs, cats, kittens, and puppies.

Southfield Emergency Management offers free disaster preparedness classes

The City of Southfield Emergency Management Division is offering free disaster and emergency preparedness classes on the last Wednesday of each month. The classes are held at the Emergency Management offices located in the basement of the Southfield Parks and Recreation building. All classes provide participants with a step-by-step approach to disaster preparedness; how to develop a disaster plan; and how to prepare for sheltering and evacuations during times of disaster. The course provides information on possible disasters such as severe weather and tornadoes and addresses how to prepare for them. All participants will also receive a free disaster survival kit (\$70 value).

Upcoming classes will be held: August 29, September 26, October 24, November 28 and December 19.





PROFILE

LEADING IS FUNDAMENTAL



hen Southfield's new City Librarian David Ewick took the helm at the Southfield Public Library, it represented the culmination of decades of dedication to learning, sharing and innovating. Southfield Living sat down with Mr. Ewick to discuss his career path as well as his future plans for the library.

Q: Chart your career path to Southfield.

A: I started out in a children's library position in Shelbyville, Indiana. That was my first professional library job. I paid my dues there from the bottom up. A Children's Librarian picks out books for children to read, works with kids, and handles a lot of kids programming. There were only three male children's librarians in Indiana at the time. What was neat was that so many kids didn't have positive male role models, so it was fun and humbling to serve as a role model to those young kids.

I then took a position as an audio visual librarian in Franklin, Indiana, which was closer to home. As an audio visual librarian, I was head of a department responsible for selections of music and films while controlling a larger budget.

I became a Library Director in Rochester, Indiana, which is the Fulton County Public Library. I was there for 17 years. In that time frame, we attained a million dollar budget and built one library branch. We served 16,000 people in a predominately rural area. We made a lot of changes such as switching from

video to DVDs, cassettes to CDs, and started a CD-ROM collection of computer software. We were loaning video projectors and other equipment out to people doing presentations and were producing a lot of programs. We pushed the envelope for such a small community. We were able to do some innovative things and started an outdoor concert series during the summer, bringing in local and regional bands to perform.

Q: What attracted you to the Southfield Library?

A: I was initially thinking of moving south and not north. But the recruiter that Southfield hired called me and encouraged me to look into it. When I saw the Web site, I was drawn to Southfield. I thought I had died and gone to Library heaven. When I came here and saw firsthand the magnificent building and observed the hospitality of the staff, I was sold.

Q: What is Library Science?

A: Libraries are about sharing. We take and share things with other people and ask that you bring it back. When you have 200,000 books, 5,000 DVDs, you must have some order to it or you won't find it. The first principles that library science teaches you is how to organize things so they can be found, how to find them, and how to investigate resources and determine their credibility.

Q: If someone wants to become a librarian, what classes would they take?

A: My father, who was also a librarian, would always say that library science is biblio-therapy, in that you're helping people find the information they need to help themselves. As librarians, you must know a little about everything and a lot about nothing. A lot of librarians start with degrees in fine arts, English, history, computers and sociology. A business administration background is a good thing to have to run a library the size of Southfield's because it's like running a big business or corporation.
