INVESTMENT CONSULTANT

SouthernSun Presentation

Michael Cross, Senior Analyst & Principal of SouthernSun, attended the meeting to address their recent under performance. He discussed the sector concentrations associated with their strategy (Industrials and Cyclicals) and lack of technology exposure and the markets leadership by growth oriented sectors (Tech). He reviewed other periods of time in which the strategy has underperformed and the following periods of outperformance.

Mr. Kuhn recommended maintaining their exposure to the strategy based on longer term performance and anticipating a rotation in the market cycle.

Investment Performance Report

Chris Kuhn presented updated market values (\$117MM) as of July 13, 2018, noting that the Fund was relatively close to all targets. No recommendation for allocation changes were necessary at this time.
