# **INVESTMENT CONSULTANT REPORT**

### **Performance** Overview

Mr. Burger reported on the RHC 2018 2<sup>st</sup> Quarter performance noting that after the first quarter volatility, some relief was found in the second. Capital markets showed U.S. equities, led by energy, produced positive returns however, the international market fell. The bond market had slight negative returns.

The RHC portfolio was slightly in the black for the quarter however, alternative investment performance was not posted as of publication date.
