

As the suspects set down the items, they immediately started walking away over to a nearby Apartment Complex. As the suspects entered the apartment complex, they began throwing bricks and glass bottles at victims' vehicle, causing damage. Victim stopped his vehicle and turned around to exit the Apartment Complex due to the items being thrown at his vehicle.
