


Officers were dispatched to the 21000 Block of Indian St to assist the Southfield Fire Department and Oakland County Fire Investigator who were on scene of a residential fire. Oakland County requested Southfield PD to the scene due to a large amount of marijuana plants inside the residence.

Officers located the owner of the house and interviewed him. He gave Officers information regarding two subjects that rent the house from him. The homeowner advises he was aware that they were growing marijuana in the home but not to the extent that was in the home. He believed that the renters were legitimate caregivers and were growing the marijuana legally. The two renters were not located at the time of this investigation. The homeowner was RPI'd, and the investigation is ongoing.

On 12/28/2022, Officers were dispatched to the 28000 Block of Northwestern Hwy (Hotel) reference a customer in the lobby who had a handgun in his pocket. The front desk clerk was nervous about this and called the police.

Officers were on scene and spoke to the clerk at the front desk. The clerk stated a white male and white female were in the lobby asking for linens. The male had a handgun in his pocket. He kept his hand in his pocket on the handgun during their conversation and the clerk thought this was suspicious. As Officers were finishing up speaking with the clerk the two subjects got off the elevator and approached the front desk carrying a bunch of linens. The clerk pointed out that the male was the subject with the gun. Officer approached the male subject and asked if he was armed with a handgun. The subject stated no, the gun was in his room. Officer then asked permission to pat him down. The subject then said that he did have the handgun on him, and it was in his waistband. Officer located the handgun which was tucked in the waistband of his pants on his right side. Officers took possession of the handgun which was loaded with a magazine and a round in the chamber. The subject was asked if he had a Concealed Pistol License. He said he did not. Officers confirmed that the subject did not have a CPL.

The handgun registered to the female that was with him. He was carrying the handgun because he did not want to leave the handgun in the hotel room. He was taken into custody w/o incident for CCW.


25000 Block of W Twelve Mile Rd.

(Apartments)

On 01/01/2023 Several Officers responded to the 25000 Block of W. Twelve Mile (Apartments) regarding two subjects with flashlights, breaking windows on vehicles. When officers arrived on scene one Officer positioned his patrol vehicle blocking the eastern entrance/exit of the complex while other officers conducted an area check inside the complex. Shortly after entering the complex Officer advised, he observed a White Hyundai Elantra traveling towards the exit at a high rate of speed and advised the vehicle was occupied by two subjects. Officer positioned at the exit observed the vehicle coming towards the entrance. The vehicle was occupied by two black males wearing face masks partially covering their face.

Flee and Elude: As Officer attempted to approach the vehicle the suspects stopped and put their vehicle in reverse and turned around. The vehicle began traveling WB through the complex while accelerating in speed. The vehicle continued to disregard officers with their lights and sirens activated and continued to flee. The vehicle was fleeing WB through the complex and turned left to go towards the exit. Officer executed a PIT maneuver striking the vehicle in the rear left corner panel. The vehicle began to lose control and continued towards the exit going up onto the grass. The vehicle struck another Officers patrol vehicle which had its lights and sirens activated. The vehicle was then completely blocked in at the exit on the grass embankment. Officers took the two suspects into custody. Both suspects were wearing masks and a handgun was located on the floorboard by the front passenger's feet.

Note: The pistol recovered at passenger's feet was reported stolen out from a gun shop in another jurisdiction. In September 2022, the Gun Shop was broken into when a stolen KIA drove through the building. Information Regarding Original Call LFA That Occurred at The **Apartment Complex:** R/P advised that he observed the suspects that fled from officer's break into vehicle just prior to Officers arrival. Officers discovered a white Jeep Grand Cherokee in carport with the rear passenger side window broken out. Inside the Jeep Grand Cherokee Officers observed the carpet pulled up on the passenger side front floorboard and wires exposed. (Attempt to locate a GPS tracking system and disable it). Also, in the stolen vehicle that the suspects were arrested from, a Pro-Pad tablet was located, which is commonly seen to re-program electronics systems to steal vehicles. A Southfield Police Evidence Technician processed and collected evidence from the suspects vehicle and the attacked vehicle. Both suspects arrested were Juveniles.
