

Be on the Look Out Highlights:

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you do not have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.


Merrill Ave. & Bonstelle Ave.

On February 15, 2023, at approx. 8:27am, several officers responded to the intersection of Merrill and Bonstelle to assist on a Suspicious Occupied Vehicle. Officer located the vehicle a Gray Ford Explorer parked in the middle of the street occupied. Officer ran the plate on the vehicle which came back clear. (Stolen but not reported yet) Officer observed a B/M sitting in the front passenger seat along with a B/M sitting in the driver's seat sleeping. The vehicle was running, in "park" with both front windows rolled down. Officer positioned his vehicle behind the Explorer and a second officer nosed it in. Officer approached the vehicle from the driver side, looked in the vehicle and observed a handgun with an extended magazine sitting on top of the center console. Officers requested additional units for backup. As additional units arrived on scene, the driver began waking up and saw Officers. Officers gave subject verbal commands to show his hands and to stop. The driver ignored Officers put the vehicle in gear, backed into officer's patrol vehicle and fled N/B on Merrill through the front yards. Officers pursued suspect vehicle. Suspect vehicle drove through the front yards to avoid officers and continued N/B on Rutland eventually turning W/B on Mt. Vernon. The suspect vehicle was approaching Southfield Rd. (Busy Intersection) when Officer struck the suspect vehicle to prevent further pursuit into the busy intersection. After the pursuit came to an end, it was discovered there was a 3rd B/M sitting in the back seat. All 3 occupants were taken into custody. Two of the suspects were taken to the

Juvenile Lock up due to them being under the age of 18. They were later taken up to Children's Village for incarceration.

After the vehicle was secured, Officers observed two handguns in the vehicle. One on the front passenger's floorboard and a second one in the glove compartment. Officers also observed a black "pro pad" style tablet, commonly used for the programming of vehicle ignitions on the floor behind the front passenger's seat. The suspect vehicle turned out to be a freshly stolen vehicle out of Redford. Redford PD contacted the registered owner and confirmed the vehicle had been stolen. Officers also recovered several items indicating the driver was in possession of several stolen credit cards an ATM card that was most likely used to withdraw money. The driver was in possession of a large sum of money and a window punch. One of the handguns was reported stolen. Two Southfield Police Evidence Technicians processed the recovered stolen vehicle and gathered evidence. Detectives presented case to OCPO for review. On 02/16/2023, OCPO returned with Petitions for the two Juveniles for CCW and Possession of Burglary Tools. They also returned with a 10-count felony warrant on the driver.
