


## **Special Attention: Weapons Offense**

02/26/2023 7:47pm

### Northwestern Hwy & Case St.

Officers were patrolling around Northwestern and Case and conducted a traffic stop for a traffic violation.

Officers contacted the driver and two occupants. During conversation with the occupants' officers asked them several times if there were any handguns or weapons in the vehicle. They all responded no. Officer observed a firearm inside the vehicle and all three occupants were removed from the vehicle and detained.

While looking in the back seat (Third Row) Officer observed a 12 Gauge semi-auto shotgun. The gun returned no record in LEIN. The driver advised that the gun belonged to his sister. The driver stated he removed it from the residence after a family Domestic Situation.

The gun was found to be unloaded and there was no magazine or ammunition located in the vehicle. All three occupants advised that the firearm did not belong to them, and the owner was not located. The weapon was taken for safekeeping and the driver was advised to have the registered owner make the station to pick up the property. The driver was issued a violation for DWLS and released. One of the other occupants took over the driving.

# Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you do not have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

# **A&B Police Officer/ Obstruct Police/ Disturbing the Peace- 2- Arrests**

#### (Apartment Complex)

Officers were dispatched to the 23000 Block of Providence Dr (Apartment Complex) regarding a Domestic Dispute.

Note: Officers were dispatched earlier to the same area for two subjects fighting in the parking lot. The two females were in a Chrysler Minivan. The two females did not wish for police assistance at that time. In the second incident R/P advised the same females were fighting again near a gold minivan and throwing items at each other. Officers arrived on scene and located the same two females in the same vehicle. When Officers contacted the driver, she had a visible injury, and she was advised they were investigating a possible A&B. When Officers asked the driver for her ID the driver refused to identify herself. After several attempts to identify the driver, she was taken into custody for Obstructing a Police Investigation. When the passenger observed this, she became upset that Police arrested the driver, and she became disorderly and attempted to intervene. When her advances were blocked by officers, she swung at Officer. When Officers attempted to take the passenger into custody, she resisted arrest and sat on the ground refusing to walk to officer's police vehicle after being hand cuffed. Officers had to use the necessary force to get passenger to their police vehicle and while attempting to get her into the police vehicle she kicked a female officer several times in the stomach and chest. She continued to resist officers getting into & out of the police vehicle & while being transported to the jail. She was charged with Disorderly Person and Assaulting a Police Officer.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

## **B&E/ Possession of Burglary Tools-** 1- Arrest

### (Office Building)

Officers were dispatched on a B&E in progress in the 16000 Block of Northland Dr. Information given was the caller was watching a person wearing all black break into the building with a hammer.

The caller has cameras within the building, and he receives motion notifications and was watching the suspect via the camera.

Officers arrived on scene and met with the night manager who was

also called to the scene. Additional information was given that the suspect entered the building through a window. The suspect was described as wearing all black with a black hoodie over his head. Officers began searching for the suspect.

Officers observed a black male wearing all black walking south towards Eight Mile Rd. The male continued to walk south to the median on Eight Mile. Officers contacted the subject. The suspect was verbally identified and patted down for officer safety. Officers checked subject for weapons and felt a large bulge in his front hoodie pocket. Officers recovered a light that would be worn on your head, two saw Zaw blades and a pair of gloves from the subject. The subject also had a deep cut that was bleeding from his left pinky finger. The subject told officers he was looking for a place to sleep and made statements that he was the only subject involved in this incident. He was taken into custody for B&E & Possession of B&E Tools. The suspect was later interviewed by Southfield Detectives. He made admissions to cutting the fence to enter the property & breaking into the building using a rock to break out the glass. He cut his finger exiting out the window he had broken out. Case was forwarded to OCPO for review.

# R&C Stolen Property/ CCW/ Obstruct Police- 1- Arrest (Also, A&B Investigation)

02/21/2023 2:55pm

22000 Block of W Ten Mile Rd.

(Commercial-Restaurant)

On Tuesday 02/21/2023 Officers were near the 22000 Block of W Ten Mile Rd. regarding a dispatched call where the caller stated an unknown male in a black truck was chasing someone with a firearm. Additionally, the caller stated a male possibly involved in the incident was seen getting into a Silver Malibu.

Once in the area, officers located the Silver Malibu. Contact with the driver was made who stated he was an Uber driver. Officers observed a younger B/M sitting in the rear seat of the vehicle and contacted him. He was found to be in possession of a handgun, and he attempted to flee from officers. He was apprehended and taken into custody for CCW and R&O. A Southfield Police Evidence Technician recovered the handgun and ran the Serial# through LEIN via Dispatch. Dispatch advised the Pistol was stolen out of Westland on 12-11-2022.

Additional charges for Possession of Stolen Property.

The subject told officers; he was at business ordering some food. When he left, an unknown male tried to "jump' him. He further explained the individual grabbed his hoodie with 2 hands and threw him; he lost his balance but did not fall to the ground. The only description of the unknown male was that he was dark skinned and wearing a dark hoodie. The subject never mentioned anything about a firearm or handgun.

**Note:** Officers reviewed Surveillance Video of the initial incident that occurred in the 22000 Block of W. Ten Mile Rd. (Restaurant) It shows arrestee getting dropped off in a Silver Malibu. He walks into business. Three Younger B/M's, one dress in a black hoodie with white writing on the front, black adidas pants with three white stripes down

the leg and black shoes exits a dark colored Ford Edge and walks towards business. The arrestee opens the door to business and as he is walking out with his food one of the males grabs onto his shirt and throws him towards the parking lot. Arrestee does not fall. He chases the subject through the parking lot. As he is chasing the subject through the parking lot, he pulls out a handgun and points the weapon at a heavy build B/M who came with the subject that assaulted arrestee. Arrestee then turns his attention to the person who assaulted him, chases the subject across 10 Mile Rd. while still armed with the handgun. The subject being chased then runs back onto Ten Mile Rd and is picked up by the Ford Edge he arrived in, and it flees w/b Ten Mile Rd from Lahser Rd. Arrestee runs back across the street where the incident started, picks up his backpack and then gets back into the Silver Malibu he arrived in. Shortly after this Officers contacted the Silver Malibu and arrestee.


