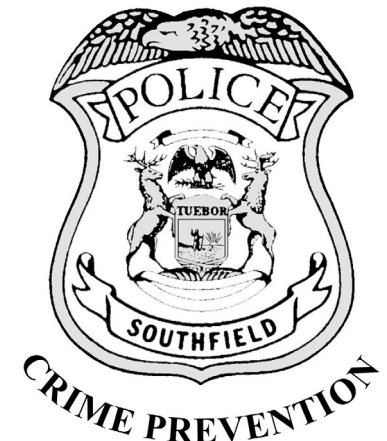
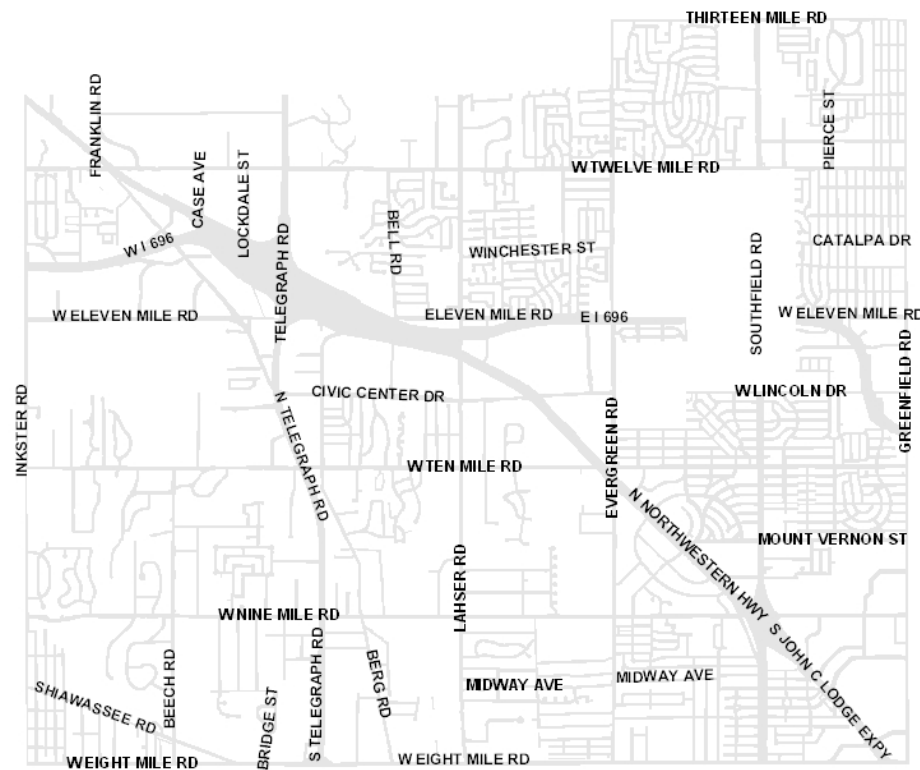

Dispatch advised the RP/victim, called, and stated two people approached his vehicle and robbed him at gunpoint. <b>The suspect vehicle was a Gray Chrysler 200, two B/M suspects in their 20's, wearing black, and were armed with handguns.</b></p> <p>There was a third suspect (driver) that never exited the suspect vehicle. Victim's backpack and handgun were stolen.</p> <p>Victim advised when the two suspects entered his vehicle the suspect in the back seat pointed his gun at him and told him not to move. Victim had his handgun under his right thigh. The passenger suspect noticed the handgun and grabbed it from victim. Both suspects then fled the area in the Gray Chrysler 200.</p> <p><b>Victim describes the back seat suspect as a light skin B/M, 20s, wearing a black ski mask, and a white hoodie, unknown pants. The front seat suspect was a medium brown B/M, 20s, wearing a black ski mask, and a black hoodie, unknown pants.</b> Victim states he did not know the suspects and did not recognize their voices when they were talking. Officers questioned victim as to why he pulled into the parking lot and why was</p>

			<p>he at the hotel. His answers were suspicious which brought to question why he was there and what really happened.</p> <p>Officers observed surveillance video of incident. The suspect vehicle was observed backing into parking space. Victim is observed then parking next to the suspect vehicle. Two suspects are then observed exiting their vehicle and they enter victim's vehicle w/o incident. They are only in victim's vehicle for a few seconds, and they exit. Neither suspect seems to be in any hurry, and they re-enter the suspect vehicle. No handguns were observed. The victim leaves in his vehicle first and the suspect vehicle follows behind him? The victim then returns approx. 2-3 minutes later to the area where incident took place. Appears to be more to the incident then what the victim is telling.</p>

**Special Attention:**

**Larceny of Packages that were ordered and delivered via Common Carrier.**

**How to prevent this from happening to you!**

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

**Auto Theft- 1- Arrest**

**28000 Block of Telegraph Rd.**

On 2/11/2023, Officers were dispatched to the 28000 Block of Telegraph Rd. (Car Wash) Someone had called stating a black male wearing all black had tried to get into a grey vehicle and drive off. Several people were currently holding suspect down. Officers arrived on scene and handcuffed the suspect to detain him while officers completed their investigation.

Investigation revealed that the victim worked at the Car Wash. He was uncooperative with officers and stated he did not want to waste anymore of his time with this incident. They stopped the crime from happening and officers can decide what to do with the suspect. Later the victim stated he did not wish to prosecute because he felt that there was something wrong mentally with the suspect. Victim stated he believes the suspect suffers from mental illness due to the suspects bizarre behavior. After further investigation and speaking with the suspect it was decided that the suspect would be RPI'd and transported to local Hospital for Mental Health Evaluation.

**Special Attention: Larceny from Vehicles**  
**How to prevent this from happening to you!**

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you do not have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

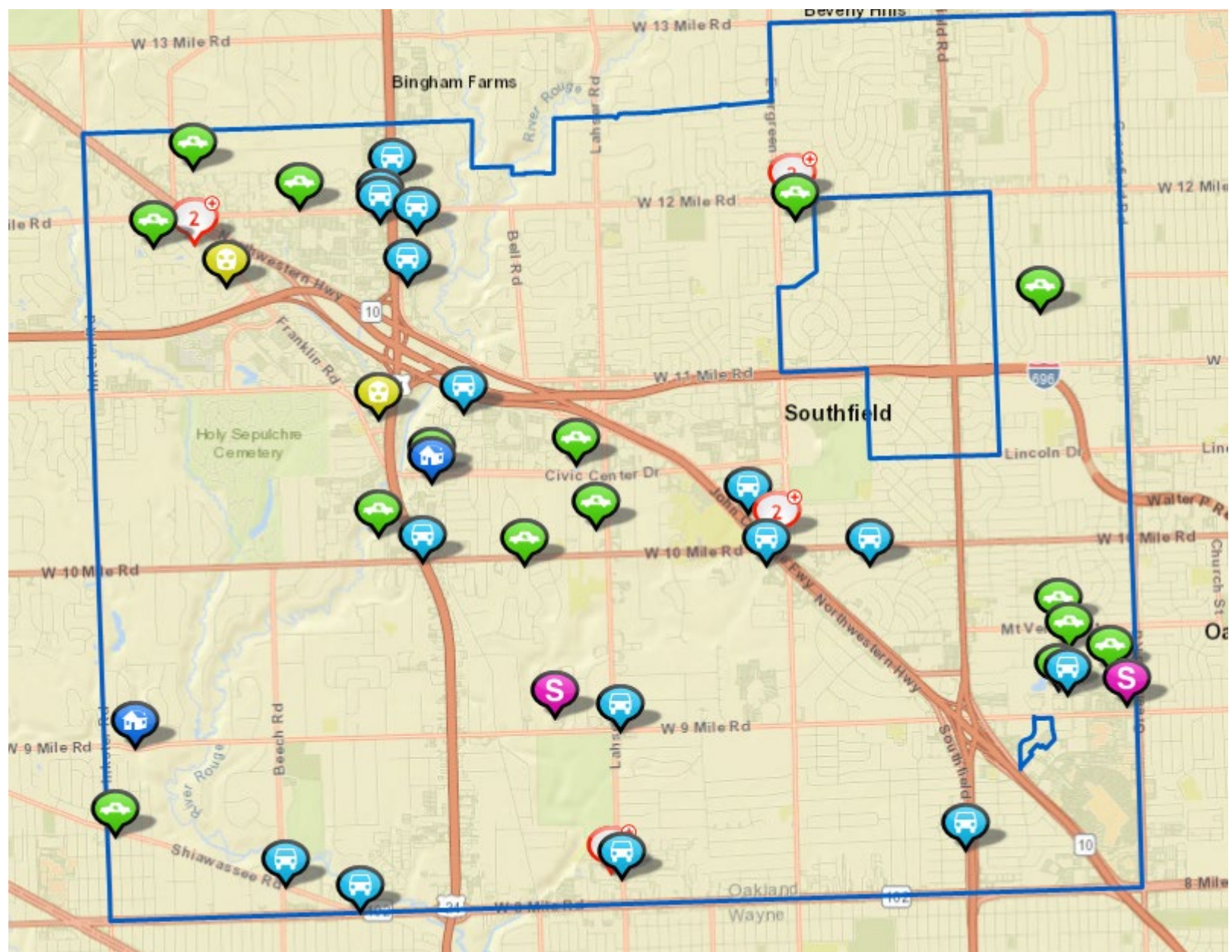
**28000 Block of Franklin Rd.**






### **(Apartment Complex)**

On 02/12/2023 Officers responded to a dispatched run in the 28000 Block of Franklin Rd. (Apartments) in which a female stated that she had just been robbed. Officer met with the female victim and interviewed her. Victim stated she was with a female friend (Suspect#1) at a party in Detroit. They decided to go back to her apartment in Southfield. Victim states the female friend let an unknown male (suspect#2) into her apartment. **Suspect#2 was a very tall B/M, skinny, wearing a camouflage mask, tan or grey hooded sweatshirt and jeans.** The male told victim to give him her money and grabbed her cosmetic bag that she keeps her money inside of. The bag was on the floor next to her bed, so victim assumes that her female friend told the male suspect where the bag was. She described the bag as a smaller, yellow cosmetics type bag with sunglasses printed on the outside. The bag contained an undisclosed amount of cash, her bank card, and her Michigan ID. Victim attempted to tussle with the male suspect to get her bag back from him, but he grabbed her by the neck and threw her to the ground. He told her he would kill her and while she was struggling with him initially, she could feel a gun in his waistband. While she was on the ground victim's female friend (Suspect#1) tased her in the right leg and then ran out of the apartment with the male suspect. During Officers investigation it was discovered that the victim may be involved in prostitution. The victim denied the allegations even though there was evidence to suggest otherwise. Officers located the female suspect walking w/b on the main driveway of the condo complex adjacent to apartment complex where incident occurred. Officer stopped the female and questioned her. The female stated she was fourteen years



of age, and that officers needed to call her mother. She also told officers that she has a taser and had defended herself against "that other female", referring to the RP / victim. The female continued to pull away from officers at which point she was handcuffed and secured while officers completed their investigation. She was eventually taken into custody for Armed Robbery & Felonious Assault. She was escorted to Officers patrol vehicle. Once at the vehicle, she refused to get in, kicking the door and the panels of the vehicle. After she was placed into the patrol vehicle, she began to kick the rear driver's side door of the patrol vehicle. Leg restraints were used to secure the female suspect. The female's guardian (mother) was contacted, and she came into the station to speak with Officers. The female (suspect) was later transferred to Children's Village. Investigation is on-going.
