


After the consensual sex was over the male requested additional sexual acts. Victim refused and the suspect threatened her with a knife. No suspect information.</p> <p>Special Attention: Larceny of Packages that were ordered and delivered via Common Carrier. How to prevent this from happening to you! Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Special Attention: Larceny from Vehicles

How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. On 02/07/2022 Officer was traveling N/B Evergreen Rd. when he observed a Black Honda Civic. The license plate expired on 03/12/2021 and the vehicle was stopped w/o incident. During the traffic stop the driver made admissions to having a loaded handgun in his backpack which was on the passenger seat of the vehicle. The driver did not have a valid CPL. A second Officer arrived on scene and a handgun was recovered in the driver's backpack. The driver was taken into custody for CCW. A Southfield Police Evidence Technician recovered and placed the handgun into SPD evidence. The driver was conveyed to the Southfield Jail where he was processed and lodged.

Possession of Meth & Narcotics Paraphernalia/ No Insurance

W Eight Mile Rd. & Berg Rd.

Officer was on routine patrol on 8 Mile Road near Evergreen Road when he observed 2013 Ford Fusion. The license plate was expired and the vehicle had no insurance. The vehicle was stopped and contact was made with the driver.

After confirming the plates were expired and there was no insurance on the vehicle it was determined that the vehicle would be impounded. During the inventory search of the vehicle Officer located narcotics paraphernalia and suspected methamphetamine in a cloth bag in the center console. The driver was arrested for Possession of Meth & Narcotics Paraphernalia. A Southfield Police Evidence Technician Field Tested a sample of the suspected substance. The result was positive for possible presence of Meth. The driver was conveyed to the Southfield Jail, processed and lodged.

(Commercial- Home Goods & Groceries)

Loss Prevention from business advised they became aware of Retail Fraud after an unknown customer observed one of the suspects exiting the store with a basket of unpaid merchandise and alerted security. Surveillance video of the parking lot captured a White Chrysler Pacifica. Four suspects exited the vehicle and entered the store. The suspects go directly to the liquor aisle and each begin to select various bottles of alcohol. All four suspects exit the store without making any attempt to pay for the merchandise. Shortly after this the incident was reported and Officers were dispatched to the store for a report. Southfield Officers located the suspect vehicle and the vehicle was stopped w/o incident. The four suspects that were in the vehicle were taken into custody. Four baskets filled with liquor from the business were recovered from the vehicle.
