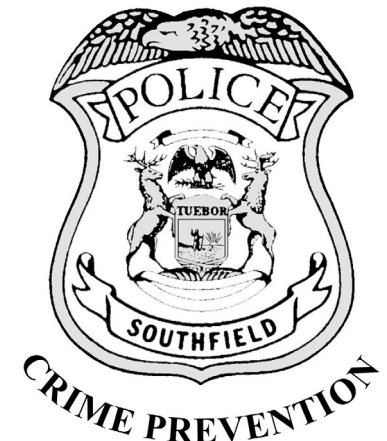
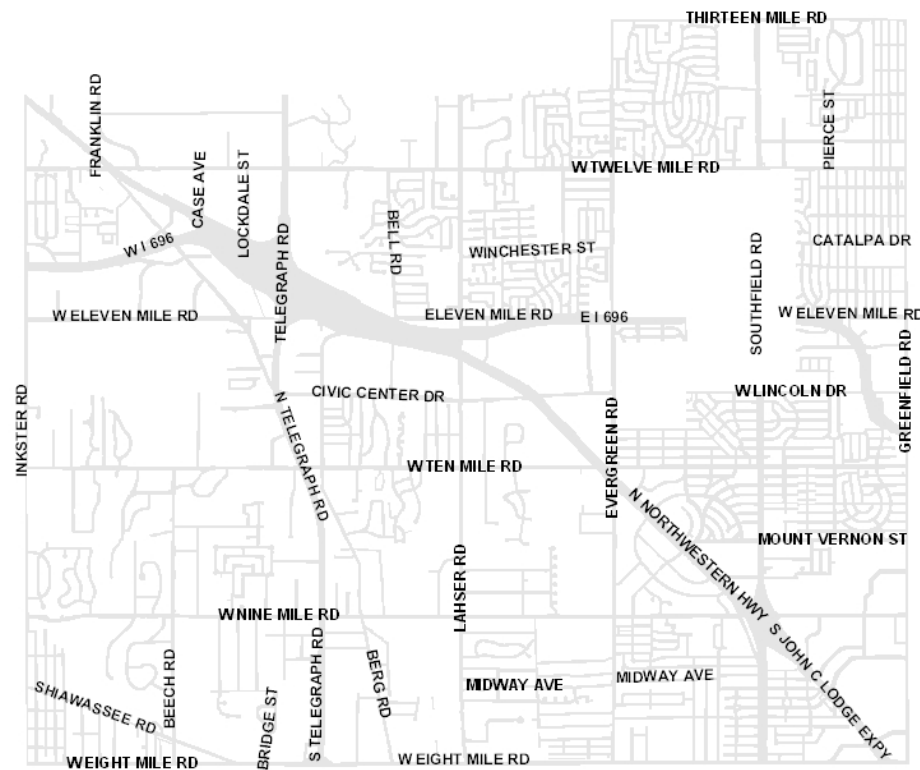

(Apartments)	Door to apartment was kicked in and the glass was broken out.	<p>On 01/23/2023 at 6:58pm Southfield Officers were dispatched to the 15000 Block of W Eleven Mile Rd. (Apartments) for a Domestic Assault Investigation. Both parties involved called 911. The female stated she was assaulted. The male half stated the female was kicking in his door to his apartment and she broke out the glass.</p> <p>Officers arrived on scene and observed broken glass on exterior door on the west side. Officers also observed the door to apartment slightly ajar, with fresh damage to the door frame and deadbolt. Officers announced their presence and there was no response. Officers cleared the interior of the apartment, and nobody was found inside.</p> <p>Shortly after this the male showed up. He advised officers that he picked the female suspect up earlier in the day and brought her back to his apartment to hang out. They got into a verbal argument, and he decided to drive her back home. As they were</p>

			<p>walking out to his car the female continued to be irate, so he decided not to give her a ride home. The female then threatened to mess things up and started kicking the glass on victim's apartment door. Victim called police and drove away to avoid further confrontation. Victim stated no assaults occurred. After speaking with Officers victim checked his apartment. Besides the damage to the door, he does not believe anything was taken. The female was not located at the time of report. The female has been identified and investigation is on-going.</p>

01/25/2023 5:44am	26000 E Carnegie Park (Apartments)	Apartment Door was kicked in.	<p>On Wednesday, 1/25/2023 Southfield Officers were dispatched to the 26000 Block of E. Carnegie Park (Apartments) for a reported Home Invasion. Officers contacted the victim who was outside her apartment waiting for officers in the parking lot. R/P states she was in her apartment when she heard what sounded like her front door being kicked in. She did not initially check the door until about 30-40 minutes after the occurrence and that is when she discovered the damaged door. She then left the apartment to await police arrival in the parking lot. Officers went to victim's apartment and observed the front door kicked in. There was a shoeprint on the center of the door and the trim around the door latch was torn away and several wood pieces were lying on the ground. A Southfield Police Evidence Technician responded to the scene for processing. Victim believes that the suspect could be her ex-boyfriend who has previously kicked in her door in a prior incident. Investigation is on-going.</p>

01/28/2023 4:30pm	17000 Addison St.	Front window was broken out.	<p>On 01/28/2023, Southfield Officers were dispatched to the 17000 Block of Addison St. for an unknown problem, possibly a Home Invasion in progress. Additional information was given out that the R/P's child's grandfather broke out a window on the residence.</p> <p>Officers arrived on scene and there was a White Ford F-150 backing out of the driveway. The vehicle was occupied by the R/P's child and his grandfather. The vehicle was stopped, and occupants were questioned. Officers also spoke to the R/P who was inside the residence.</p> <p>R/P is disabled and in a wheelchair. She has caretakers that were present during the incident. R/P advises she requested her son to take a shower because he was supposed to be going to his father's house today. R/P's son (Age 7) refused and when the caretakers attempted to intervene, he assaulted both the caregivers. R/P's son called his father and told him what was going on, so he sent the grandfather to come pick up his son.</p> <p>When the grandfather got to the house, he was outside the home banging on the front glass window threatening to beat up R/P and her staff. He continued attempting to get in until he broke out the glass on the front window. The grandfather then stepped into the house and grabbed R/P's son and fled to his vehicle.</p> <p>The grandfather was interviewed, and he made admissions to braking out the front window to the residence and stepping into the residence to grab</p>

			<p>R/P's son. He was taken into custody for Home Invasion and MDOP.</p> <p>A Southfield Police Evidence Technician responded to the scene to take photographs of the damaged window and the caretaker's injuries.</p>

Methamphetamine – Possess 1- Arrest

Officers were on routine patrol when they observed a Black Mercedes commit several traffic violations. The vehicle was stopped by Officers and there was a lot of furtive movement prior to the stop from the driver. Officers contacted the driver and requested he exit the vehicle because of the furtive movement. The driver was very nervous. Officers requested a search of the subject, and he consented. As Officer was patting the subject down, he observed a small clear vile fall out of the driver's right sock. The vile had a small clear rock inside, consistent with meth. Officers asked the driver what was in the vile. He stated "Meth" and went on to say he was just a user and he had just purchased the meth from someone at the hotel he was at. The driver was taken into custody for VCSA. Inventory search of the vehicle a meth pipe was located on the front seat. The pipe and suspected meth were both secured as evidence. A Southfield Police Evidence Technician met with Officers and Field Tested a sample of the suspected substance. It tested positive for possible presence of methamphetamine.

On January 27, 2023, at approx. 9:25am, Officer responded to Telegraph Rd. and 10 Mile Rd. to conduct an area check for a vehicle involved in a Home Invasion. The suspect vehicle was a newer model, black, Chevrolet, Malibu. The suspect involved was a female, wearing a red jacket, with a black stripe, grey hood, and grey pants. While monitoring southbound traffic on Telegraph Rd Officer observed a vehicle matching the description traveling s/b on Telegraph Rd. The vehicle had tinted windows and was stopped in the parking lot in the 24000 Block of Telegraph Rd (Gas Station).

Officer contacted the driver and two other occupants. All the occupants were identified. The driver was wearing an orange coat, grey winter hat, and dark pants. There was also an orange hoodie with a black/dark blue stripe down the side sitting in the back seat. Additional units arrived on scene to assist w/ the investigation.

During this investigation, the driver stated that they went to one of the occupants in the vehicles house on Tavistock and they were going to hang out there if her mother was not there. The girls were all skipping school. The driver stated she only knocked on the door she never entered the residence. The Home Invasion was never confirmed. The homeowner's daughter stated the driver only knocked on the front door and they were skipping school and were going to hang out at her residence if the mother was not there. Further investigation by Officers they discovered a handgun in the map holder on the driver's door of the suspect vehicle. They also recovered a Stun Gun in the rear passenger's purse. The two juvenile females were taken into custody for CCW. All the juvenile's parents were notified.

Investigation is on-going.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Special Attention: Larceny from Vehicles

How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

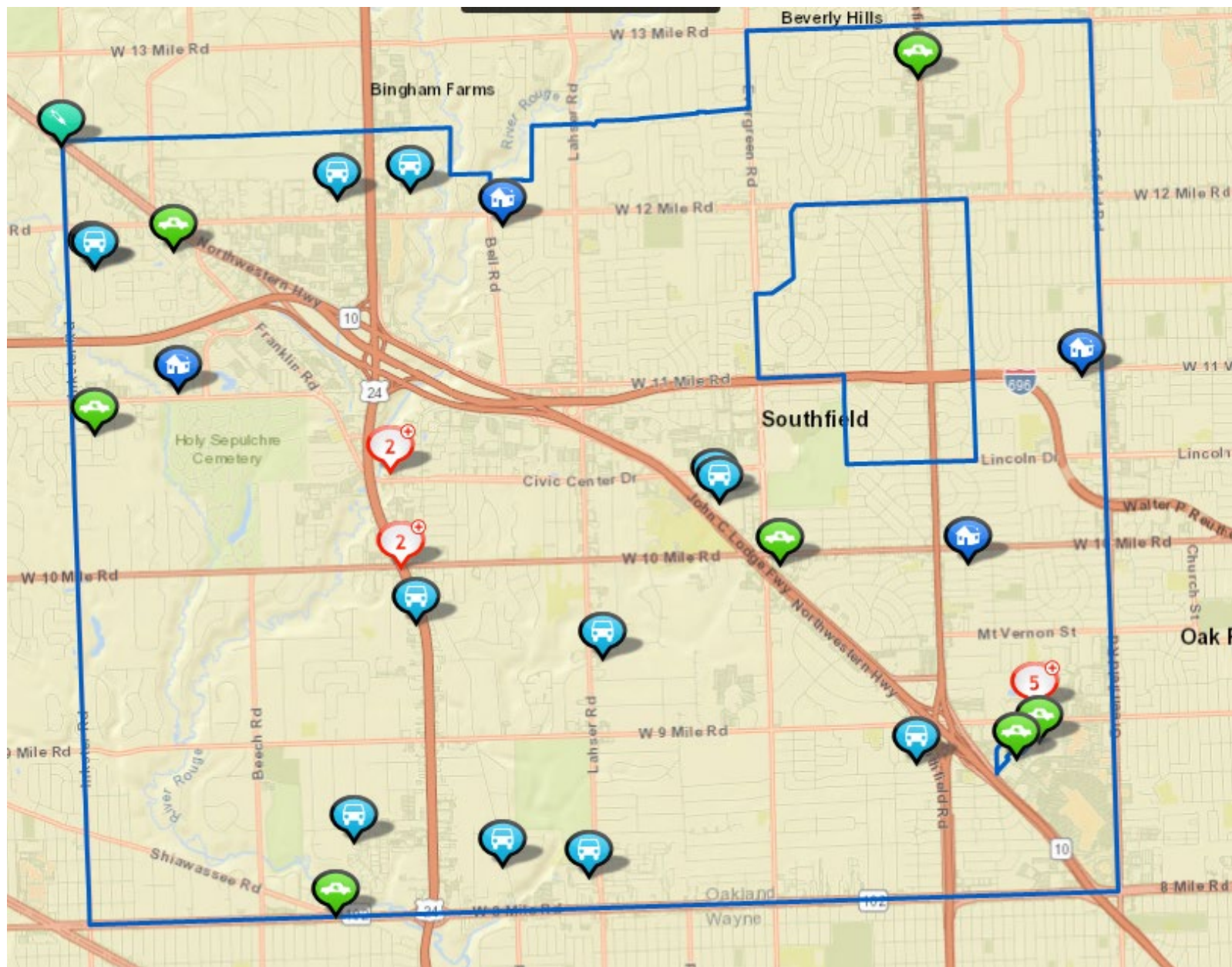
-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.






-If you do not have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals do not like to work in well lighted areas. They prefer to work in darkness because it is difficult to see them.
