


On 01/16/2023 Officers were dispatched to the 26000 Block of Stanford Dr E (Town Homes) for a vehicle fire that appeared to be arson. The caller stated someone set her vehicle, a White 2022 BMW X4 on fire.

Officers arrived on scene and the Fire Department was extinguishing the fire. Officer's spoke to the victim who was very upset. Victims' cousin was able to pull up Ring Doorbell footage of the incident. The footage showed the fire igniting and engulfing the vehicle in flames followed by two unknown males running westbound. Both subjects got into a vehicle (Dark SUV), which was already running. The suspect vehicle was in the parking lot about 50 feet west of the attacked vehicle and left westbound. The footage did not show anything prior to the fire igniting.

The victim later stated she has been receiving phone calls that were threatening in nature. She does not know who the caller is. She gave the information to officers investigating.

A Southfield Police Evidence Technician responded and processed the scene and took photos of the damage to the vehicle. While checking the area Officers located a red five-gallon gas can in the

While on patrol, Officer observed a male and female arguing in the parking lot in the 16000 Block of W. 9 Mile. Officer observed the female, "squaring up" with the male half, getting in his face and bumping him with her chest. Officer separated both parties and spoke with the male. A second officer arrived and spoke with the female. Investigation revealed that the female assaulted the male, and his lip was bleeding. Officers took the female into custody for Domestic Assault. Once up in the jail, the female was taken directly back to a single confinement cell, due to her behavior. She was very combative with the officers. While walking the female into the cell, she snorted as if she was attempting to spit on officers. She was positioned on the floor so she could not spit on officers and her handcuffs could be removed. When the handcuffs were removed from female, Officers attempted to leave the cell. The female was told to stay on her knees until officers left. Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you do not have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately calls 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the

suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.



Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
