

On 07/15/2022 at 11:20pm Officers were dispatched to the 21000 block of Hilltop St reference juveniles drinking and yelling at people. Upon arrival, Officers observed a large crowd of individuals (approximately 100) in the parking lot yelling and loitering. Officers activated overhead lights and siren to announce their presence and used PA system to tell the crowd to disperse. The crowd was cooperative, and multiple individuals were entering their vehicles and leaving the area.

A short time later several gun shots were heard coming from the area. Officers moved into that area to investigate and observed five subjects. One of the subjects was bleeding from his hand and was yelling "I've been hit" This subject was walking away from Officers at a fast pace. Officers stopped and detained this subject. A knife was found on this person. As Officers were investigating several subjects starting coming at Officers in an aggressive fashion. Officers moved with the detained subject back to their vehicles as quickly as possible.

The subject told Officers that he wasn't shot, that he had cut himself with his knife and he was refusing medical treatment and refusing to cooperate with Officers.

Officers searched the area and located several spent shell casings and a blue cell phone.

Other Officers that were in the area located a suspect vehicle at 8 Mile & Bridge St. The vehicle was a Black Ford Flex that was occupied by two subjects. Officers observed a handgun on the center console next to the occupants. Officers secured both occupants in the vehicle and the handgun was recovered from the vehicle. Officers located a second handgun on the passenger in the vehicle. Both subjects were arrested for CCW.

26000 Block of W Twelve Mile Rd. (Apartments)

On 07/17/2022 at approx. 3:50pm, Officers were dispatched to the 26000 Block of W Twelve Mile Rd. for reports of a CSC. The R/P advised dispatch that her niece who is diagnosed with a medical disability had an unknown male pull her pants down in the laundry room. The description provided for the male was a Hispanic male in his 20's, slim built, wearing a white or gray shirt and dark blue jeans. Officers arrived on scene and contacted the victim who was accompanied by R/P. R/P advised Officers that victim was in the process of picking up some packages in the lobby for the family. When she didn't return, R/P was sent to go look for her. R/P located victim and she could tell that something was wrong. Victim was reluctant to say anything but eventually told R/P that a male had forced her into the laundry room on the second floor and sexually assaulted her.

Officers and Detectives investigating developed a suspect and the victim positively identified the suspect in a photo lineup. The suspect was later located and taken into custody, OCPO issued warrants. 2 counts of CSC III 1 count of CSC IV
