


He arrived at the hotel a short time later and knocked on victim's hotel door. When R/P opened the door, the suspect forced his way inside and demanded her money. The suspect pushed victim to the ground causing her to skin her knee. The male produced a handgun and threatened bodily harm to victim if she didn't give him her money." The suspect started to look around the room for her money. Victim told the suspect her "Pimp" was upstairs and that he had all her money. The suspect walked victim down to the hotel lobby to try to obtain a key for her pimp's room. The suspect was still armed but the handgun was concealed. Victim was in her underwear when the suspect forced her into the front lobby. While walking to the lobby, the suspect told victim to pretend like they knew each other. At some point

during conversation with the desk clerk, the clerk must have realized something wasn't right and she stated she was calling the police. The suspect fled the hotel and victim ran and hid in the stairwell.

Victim described the suspect as a black male approx. 20-30 years old. He was 5'10-5'11 and approx. 160-170 pounds. He was wearing a black sweat suit with a blue surgical mask that covered the bottom portion of his face. He had a short beard coming out of the side of his surgical mask and a short, faded style haircut. After reviewing surveillance footage, Officers observed the suspect arrive in the 2007-2014 white or silver Chevy Tahoe. The Tahoe appeared to have no plate on it. The suspect was sitting in the passenger seat and an unknown subject was driving. The Tahoe appeared to have tinted windows with silver rims. Investigation is on-going.

(Apartments)

Several Southfield Officers responded to the 29000 Block of Franklin Rd. (Apartment Complex)

Southfield Police Dispatch received a call from a male who advised that an unknown subject who he did not know broke into the apartment.

The male advised he was scared, and he shot the subject. The male was advised to unload the gun and wait for officers. Officers arrived on scene and found one male victim lying on the living room floor unresponsive with GSW.

The victim was an ex-boyfriend of the female occupant of apartment. There were two small children in the apartment as well.

The male succumbed to his injuries. The scene was processed, and a handgun was recovered from the scene.

The male shooter was taken into custody for Negligent Homicide. Investigation is on-going

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately calls 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the

suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

R/P called the police the night of 07/19/2022 due to activity at an apartment in the 26000 Block of Berg Rd. There was extreme shouting and screaming. The male occupant dragged a woman out of the apartment and assaulted her. She pulled the fire extinguisher off the wall and began hitting the male's door with it. At one point the female started to bang on R/P's door. R/P had a box of books outside her door. The female threw them over the railing damaging the books. She called the police because she was scared since the female was banging on her door. Officers arrived on scene and the female was gone. Officers spoke to the male, and he didn't want to make any kind of a complaint. After Officers left the female returned with another female and they were knocking on R/P's door again. R/P is fearful for her safety. The females don't live there.
