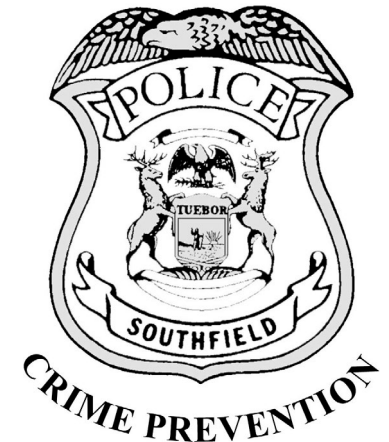
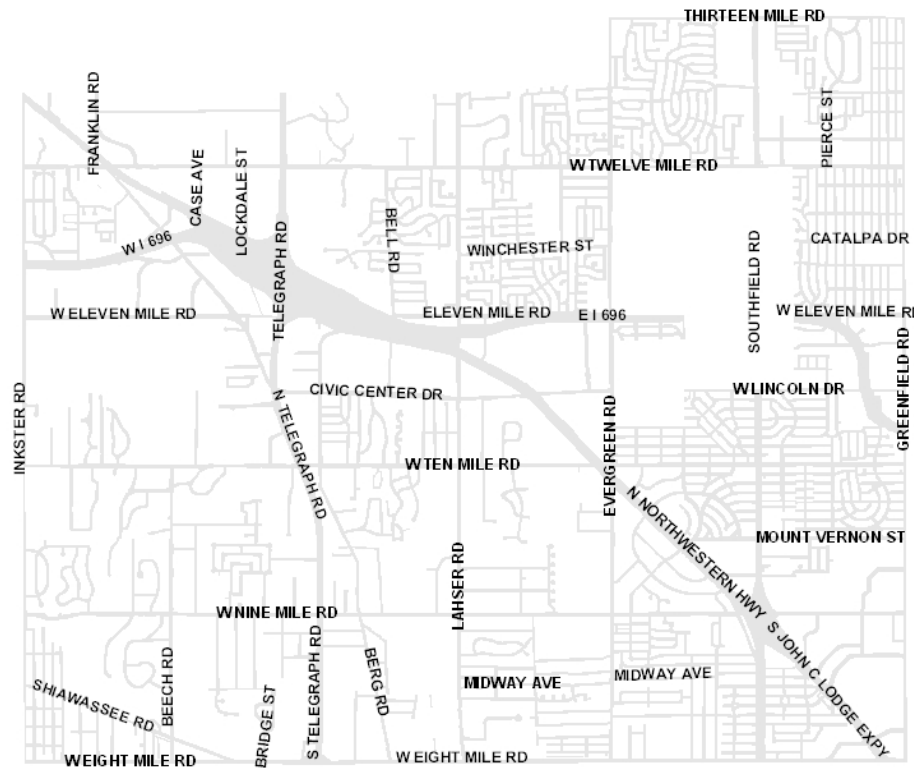

From: 06/06/2022 11:00pm To: 06/07/2022 6:00am	26000 Northwestern (Multi Office Building)	North door was pried open.	Officer was dispatched to the 26000 Block of Northwestern on a B&E report. Business was attacked between 06/06/2022 11:00pm – 06/07/2022 6:00am. Entrance was made through a north door that is easily pried open because of previous damage. On today's incident suspect cut and stole copper wiring from the vacant building. <b>Note:</b> Business was broken into the day prior as well. Appears to be the same suspects.

<p>06/09/2022 6:04am</p>	<p>26000 Northwestern (Multi Office Building)</p>	<p>North door was pried open.</p>	<p>On 06/09/2022 Southfield Officers were dispatched to the 26000 Block of Northwestern Hwy for a B&amp;E in progress. R/P/ Owner of the vacant business arrived shortly before 6:00am and observed two unknown black males inside the business. The male suspects were scared off by owner and ran out of the business towards Lahser Rd.</p> <p>One of the suspects was wearing a gray shirt and the other was wearing a black shirt and red shoes.</p> <p>Officers walked through the business with owner. The suspects cut wiring from the ceiling. One area was on the first floor and the second area was on the second floor. It appeared the suspects were removing the wiring from the ceiling to take when they were scared off by owner. There were two piles of rolled up wiring on the floor by the door. It doesn't appear that suspects took any wiring due to being scared off.</p>

(Medical Office)</p>	<p>Entry through a broken door located on the west side of the building (the door is stuck shut but if it is pulled on very hard, it will open).</p>	<p>R/P came into the front desk to report that she received notifications from her camera system that it detected motion in their medical office in the 20000 Block of Ten Mile Rd. After reviewing her video, she observed two unknown suspects forced their way into the suite by pulling on the double doors. They then could be seen walking around looking for something. Suddenly, one of them could be heard saying "that's it!" and they wheeled the machine from the office into the hallway and out of the building. R/P explained that this machine was stolen last month, and later recovered. This is the same machine and may be the same suspects.</p> <p>Note: On 06/12/22 Officer was dispatched to the 20000 Block of Ten Mile on another possible B&amp;E that occurred following the above report.</p> <p>R/P states same two b/m subjects that had stolen the medical equipment earlier in the day, had returned at approx. 10:15pm. The building was locked and secure at the time that they had returned but she believes they entered through a broken door located on the west side of the building. The same two b/m subjects quickly entered the business, very quickly looking in different rooms and then exiting.</p> <p>A sound machine was taken this time.</p> <p>Investigation is on-going.</p>

The daily operations manager also observed men breaking into the office on security cameras from her home. Officers arrived on scene and confirmed there was a good B&amp;E. The door had been forced open. Nothing was stolen. In the video footage, Officers observed 4 black males enter the office, turn on the light, and then promptly leave, pulling the door closed and turning off the light. Incident occurred between the hours of 12:05pm – 12:10pm. R/P believes the suspects were looking for a large machine that is used to correct back pain. Three of these machines have already been stolen from the business.</p>

**Special Attention: Larceny from Vehicles**  
**How to prevent this from happening to you!**

- Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- If you don't have a garage, try to park your vehicle as close to your residence as possible.
- If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Officer was on routine patrol when he observed vehicle driving with no headlights on. Officer also noticed that the front passenger side tire was shredded and was riding on the rim.

Officer stopped the vehicle and identified the driver as the registered owner of the vehicle. The owner was in Lein as having a disqualified CPL. The driver smelled of intoxicants and was given several sobriety tests. He was also given a PBT with the result over the legal limit.

The driver was taken into custody for OWI. An inventory search of the vehicle led to the discovery of a loaded handgun in the glovebox. The handgun was confiscated and placed into evidence. Second charge of CCW was added. The driver requested a blood test and submitted to same at hospital. The driver was verbally abusive to Officers and staff at the hospital and at the Southfield Jail. He threatened bodily harm to Officers and refused DNA sample. Third charge of R&O. The suspect eventually had to be placed into a separate cell at the jail due to his behavior.

**Special Attention:  
Larceny of Packages that were ordered and delivered via Common Carrier.**

**How to prevent this from happening to you!**

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Further investigation Officers recovered several tools in the vehicle that would be commonly referred to as burglary tools and used to steal copper wiring.

The driver of the vehicle was taken into custody for Possession of Burglary Tools and driving with a suspended drivers license.

The second suspect was also located in the area. He was interviewed, identified and RPI'd on scene.
