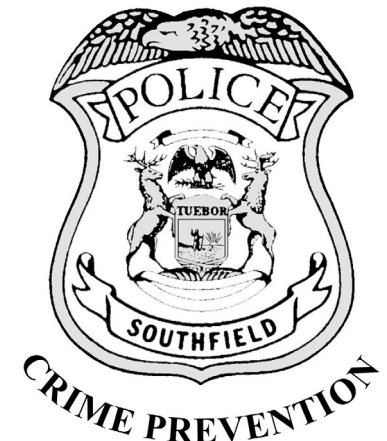
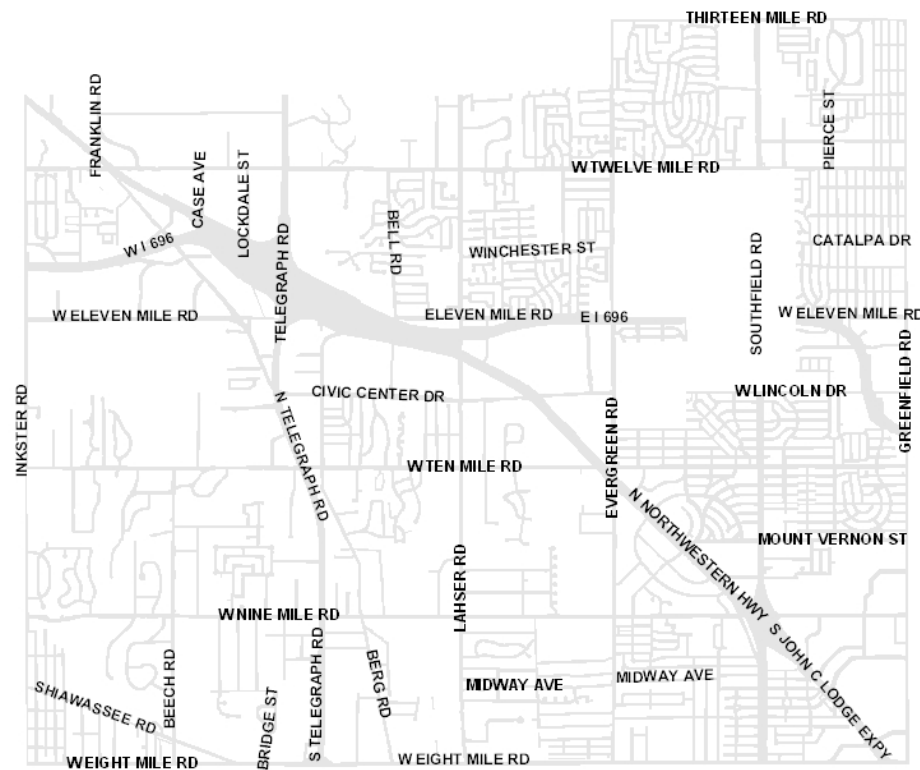

Possession of Stolen Property/ DWLS

While on routine patrol, Officer received a safety notification regarding a stolen plate attached to an Older Model Red Ford Windstar. Officer located a vehicle matching the description parked in the lot in the 17000 Block of W. 10 Mile Rd. The vehicle was backed into a parking spot obstructing the view of the license plate from roadway. Officer was able to read the plate and it returned as stolen out of Detroit on 01/20/2023 at 2:59pm.

While waiting for additional Southfield units, Officer observed a tall B/M wearing a dark colored hat and jacket exit the vehicle and walk into the nearby business. Officers set up surveillance of the vehicle. A short time later the vehicle became occupied by the same subject seen exiting the vehicle earlier. Officers stopped the vehicle and contacted the driver. He was detained and interviewed. The driver stated he knew the plate did not belong on the vehicle. He found the plate in a field in Detroit. The driver was also found to have a suspended drivers license. He was taken into custody for R&C Stolen Property & DWLS.

Special Attention: Larceny from Vehicles
How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you do not have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

(Parking Structure)**

On 03/17/2023 at 1:52am, Officers responded to the 5000 Block of Town Center regarding a domestic in progress. Dispatch advised that this was taking place on the 1st level of the parking garage. The R/P (witness) stated that a male was assaulting a female and the female is screaming. Officer arrived on scene and was informed that the male suspect had fled in a Gray Durango. Officers began to do an area check for the suspect. Officers recognized the female victim and was familiar with the couple from a residence in the 28000 block of Stuart. The victim and witness both stated the assault was physical. The female victim stated once her and suspect arrived back to the parking garage after they were out for the evening. Victim was driving her rental, dark Grey Ford, and pulled her vehicle towards her assigned parking spot and suspect was in the vehicle. Suspects friend was parked in a separate vehicle (Grey Durango). The two had gotten into an argument and the suspect was irate and went around the vehicle towards victim. She had locked the door however had the window down. Suspect then reached in, unlocked the door, grabbed victims' hair and throat simultaneously, and ripped her out of the vehicle. While dragging her out, victim was scratching and trying to stop suspect. He then threw her to the ground, started to drag her, and attempted to kick her in the face. Suspect then went in the vehicle and grabbed victims' purse, phone, wallet with credit cards, ID, & neck chain. Suspect and his friend then left in the Grey Durango. Officers located the Grey Durango parked in a driveway in the 28000 Block of Stuart St. in Southfield. The suspect was in the vehicle and taken into custody for Domestic A&B and Larceny from Person. Officers recovered victim's wallet with credit cards and ID, Gold Chain

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals do not like to work in well lighted areas. They prefer to work in darkness because it is difficult to see them.

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Note: When Officers attempted to escort the suspect to their patrol vehicle the suspect sat down and refused to walk to the vehicle.

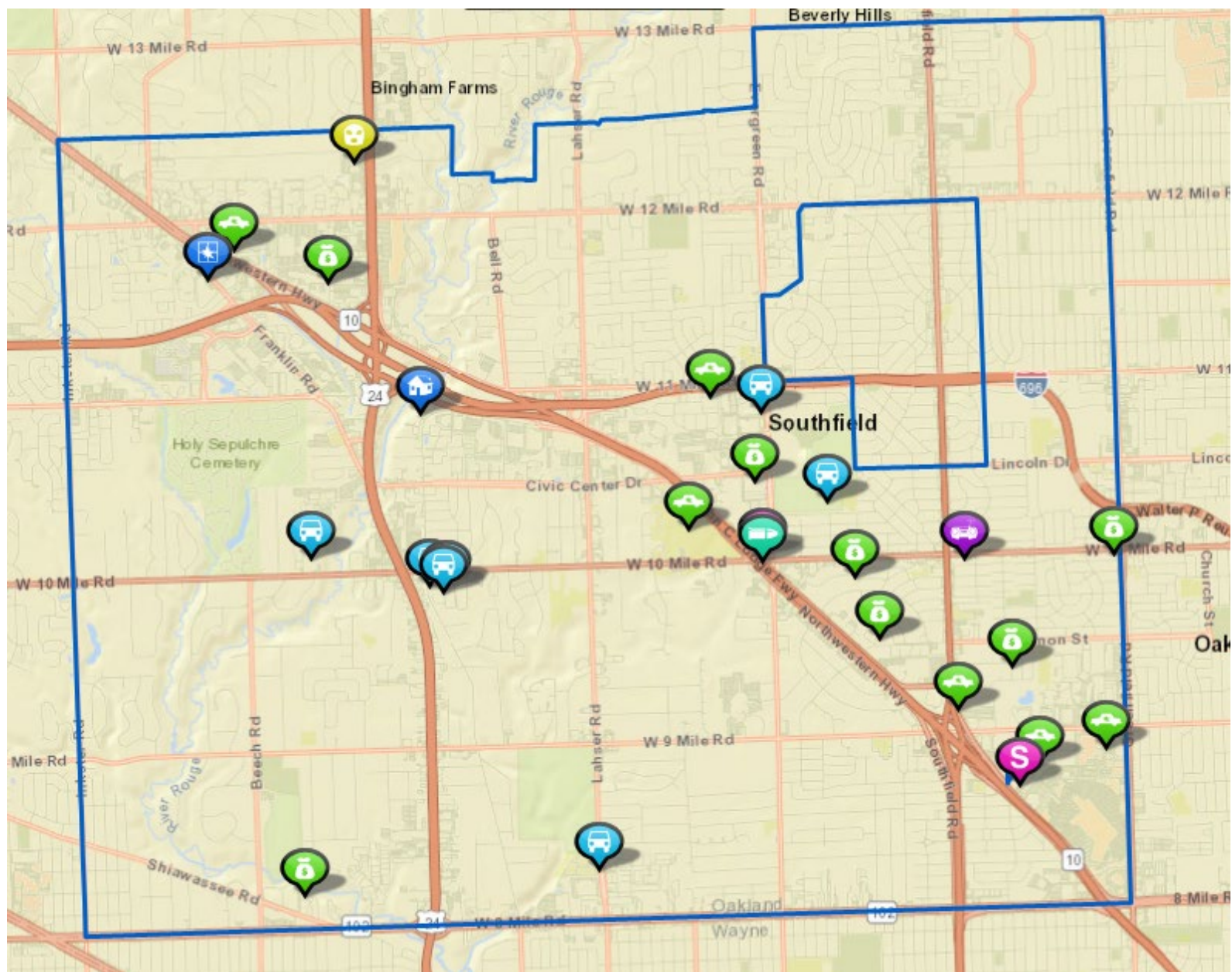
Officers had to carry the suspect to their patrol vehicle and assist him into the back seat of their vehicle. Additional charges for R&O were added to the arrest.
