



Officers had previously dealt with the subject from this residence, and he had made threats towards officers regarding harming them in the future should they encounter him. Officers entered the apartment building and observed broken glass on the ground from the housing for a fire extinguisher mounted to a wall in the hallway and a hole in the wall near R/P's apartment. Officers spoke to the occupants of the apartment (all juveniles) who stated they were ok, and the suspect had left. The lock to the apartment door had some minor damage. Officers spoke to other residents from Apartment Building. The suspect buzzed their apartments trying to get into the apartment building. Special Attention: Fleeing & Eluding/ Disturbing the Peace 04/01/2023 7:59pm 22000 Newport St. On April 1, 2023, at approx. 7:29am, Officers responded to the 22000 Block of Newport St. for a Suspicious Vehicle Police Run. While in transit to the location, dispatch relayed the vehicle involved was a Silver Jeep Grand Cherokee and the female driving the vehicle was honking her horn in front of the house. Officer arrived in the area and observed a silver, Jeep, Grand Cherokee leaving the area in the opposite direction. Officer was able to obtain the license plate of the vehicle as the vehicle passed. At that time, it was not certain the vehicle was involved in the call for service. After running the registration, it was discovered that the vehicle had no insurance, had not been registered since July of 2022, and the registered owner did not have a valid driver's license. The nature of the run was the vehicle was stopped in front of the 22000 Block of Newport and the female driver was honking the horn. The male R/P stated he knew the female suspect from a previous relationship a long time ago. R/P stated he had been receiving multiple unwanted phone calls from the female suspect as well. On the same date, at approx. 8:01am, Officers were dispatched back to the same location for the same vehicle and same suspect honking the horn in front of the R/P's address.

Upon returning officer observed the same vehicle he had observed in the first Police Run attempting to leave the residential area. With having the knowledge that the vehicle was uninsured, had expired registration, the registered owner did not have a valid Operator's license and was Disturbing the Peace. For those reasons, Officer activated his overhead lights & positioned his vehicle to stop the Jeep from its front. Officer was able to observe the suspect seated in the driver's seat. The Jeep failed to stop, instead, evaded Officer vehicle by driving to the left onto the edge of the front lawns of the houses on the East side of Newport St. The Jeep continued to flee eastbound on W 9 Mile Rd from Newport St. Officers with lights and siren activated gave chase after the vehicle. The suspect vehicle disregarded Officers emergency lights and sirens and fled E/B on Nine Mile Road. The vehicle then made an evasive maneuver through a private business parking lot by driving through the grass and on the sidewalk of the parking lot, continuing to disregard officer's emergency lights and siren. Domestic A&B/ CCW 1- Arrest 03/29/2023 7:54pm 23000 Block of Twining Dr

On 3/29/2023 Officers were dispatched to the 23000 Block of Twining Dr. for a Domestic Investigation. Involved male & female have one child in common and have been in a dating relationship off and on for 10 Years. Officers arrived on scene and located the female in the passenger seat of a black sedan. Two males were in a Dodge Ram Pick Up Truck. The female advised she was at the location to pick up her child who her grandmother was babysitting. She said her boyfriend, was there at the same time as her. She got into a verbal altercation with him while they were both parked in the driveway in separate vehicles. The altercation between her and the male was only verbal. The male half was in the driver's seat of the Dodge Ram P.U. Truck. Officers observed the male reach down towards his right hip and then placed his hands in the air. A second officer observed the driver sliding a handgun across the seat. Officer opened the driver's door and observed a handgun on the right side of the driver's seat (near where he observed subject reaching). The handgun was secured and made safe. The passenger also had a firearm on his lap. He was instructed to place his hands on the dashboard. Officers secured the handgun from the passenger, and he was identified. The passenger returned clear with a valid CPL. The passenger advised the driver is his son-in-law and (R/P) female half is his granddaughter. He arrived home and the two were arguing. He separated the two and talked with his son in law in his Ram. Officers asked the grandfather why he had a gun. He responded, because they were arguing, and he wasn't sure? Officers also interviewed the grandmother. She had a ring doorbell camera with footage of what occurred. On camera at 7:54pm, the couple were having a verbal argument in the driveway at the location. The female went to go inside, and male followed her. When the female owner of the suspect vehicle. Investigation is ongoing.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you do not have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach got to the front door, the male grabbed onto the female and pushed her into the doorway forcefully while attempting to grab something from her. The grandmother stepped outside between the two combatants and separated them. The female went inside the house. The camera then shows the male reaching down and recovers a black handgun from his right ankle and secures it on the right side of his waistband area. The male half was taken into custody for Domestic A&B and CCW.

Dangerous Drugs- 1- Arrest 03/30/2023 7:47pm W Eight Mile Rd. & Rutland Dr.

Officers were operating as a double unit. Officers were driving E/B Eight Mile Rd at Rutland Dr. Officers observed a white GMC Yukon commit several traffic violations and have expired registration (08/28/2022). Officers initiated a traffic stop W/B Eight Mile at Gilcrest. Contact was made with the driver. He was very nervous and made admissions that he knew his plates were not up to date. The driver submitted to a search of his person and officers located suspected substances. Two small baggies were in the inside left pocket of the driver's coat. One bag contained white powder; one bag contained several small pink squares. A Southfield Police Evidence Technician Field Tested samples from the suspected substances. The white powdery substance tested positive for possible presence of Cocaine. The suspect was taken into custody for Possession of Cocaine. or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals do not like to work in well lighted areas. They prefer to work in darkness because it is difficult to see them.

Special Attention: Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

He advised the suspect pulled into the driveway got out of his vehicle, and fired multiple shots and fled in a dark SUV last seen heading N/B on Fairfax Rd.

Officers reviewed the Ring Doorbell video which showed a completely different version then what the witness advised. The suspect that did the shooting was seen coming out from the residence. Investigation eventually led to the arrest of suspect for Assault w/ Intent to Murder & Possession of a Firearm in the Commission of a Felony.



Officer observed a black Nissan Altima parked in the back of the parking lot. The vehicle was parked outside of room where incident occurred. He observed the vehicle was occupied by a B/M wearing all gray in the driver's seat of the vehicle. Officers contacted the occupant who was identified by Michigan Driver's License. Officers questioned the subject and he advised that he just got to the hotel, and he never got out of his car. While Officers were speaking with the subject in the parking lot additional officers spoke with the R/P (victim). After telling Officers what happened, Officers asked the victim to look out the window and see if the subject that officers were speaking to is the subject that assaulted her. Victim advised that it was. The suspect was taken into custody for CSC I and B&E of the Hotel Room. The victim later refused to submit to a CSC Exam. Investigation is on-going.
