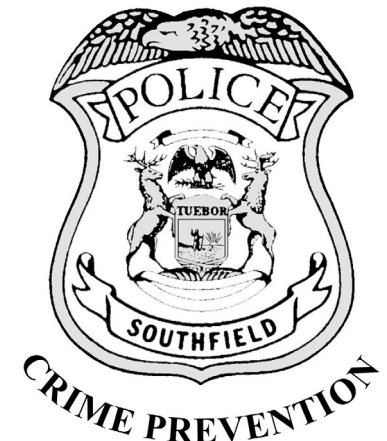
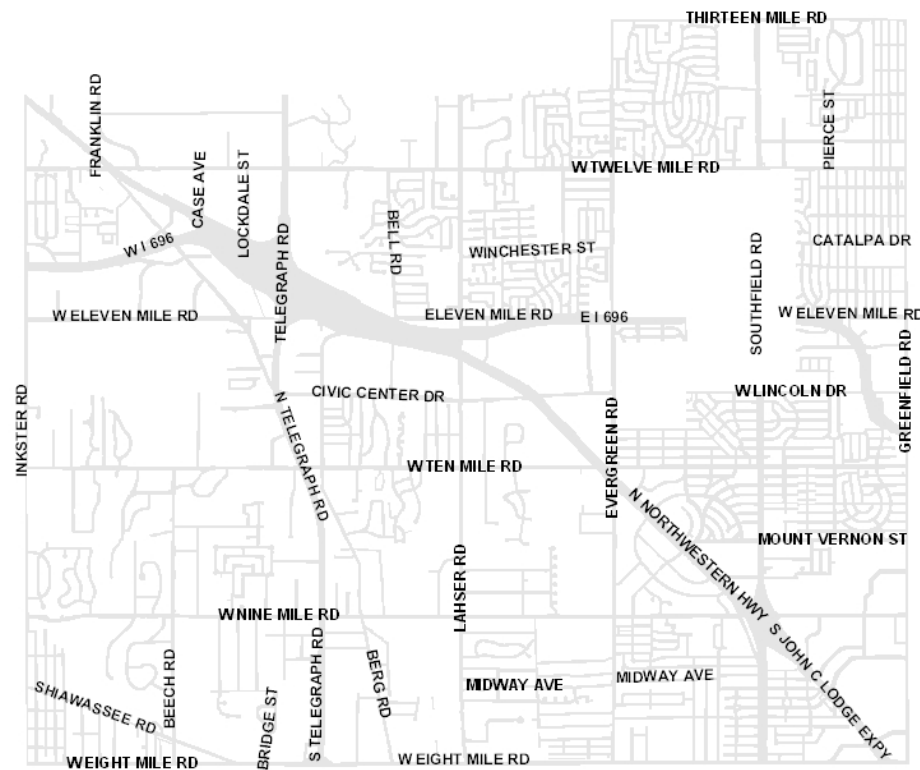

On 03/06/2023 at approx. 9:50pm, Officers were dispatched to the 27000 Block of Greenfield Rd. (Apartments) for reports of a Domestic Disturbance. The first female caller stated she needed police then disconnected. The second female caller, (First callers' sister) stated there was a Domestic Assault in progress between her sister and her boyfriend who live together at apartment complex.

When Officers arrived on scene and located the two combatants. At this time, Officers separated the two combatants and interviewed both and the female's sister. The male half claimed that the two sisters both assaulted him when he was attempting to get his girlfriend to come home. The two females advised they were assaulted by the male. After completing their investigation Officers took the male half into custody for Domestic Assault. Officers located an unloaded handgun on his person when taken into custody. A Southfield Police Evidence Technician took photos of everyone's injuries.

The case was submitted for charges of Domestic Assault vs the girlfriend, Assault and Battery charges vs the girlfriend sister, and CCW charges against the boyfriend as he does not have a valid CPL and was in possession of the pistol outside the curtilage of his home.

Officers were dispatched to the 21000 Block of Duns Scotus to contact 15-year-old female who was allegedly involved in an assault/robbery that occurred at the Apartment Complex.

Officers interviewed the 15-year-old female, and it was looking like this was a possibly a CSC and assault. The female showed up at her boyfriend's residence nearby wrapped up in a blanket and told her boyfriends parents she had been sexually assaulted. She advised that the assault happened in the 25000 Block of Lahser Rd. in an Apartment. The female stated that her mom and her lived across the hall from the suspects apartment. They had been kicked out of their apartment and the suspect allowed them to stay with him until they got things sorted out. At some point victims mother left the suspects apartment leaving her 15-year-old daughter at the neighbor's apartment. During this time, the 15-year-old victim fell asleep on the couch. That is when the suspect touched the juvenile inappropriately. When the 15-year-old victim realized what was happening she got up to leave the apartment the suspect accused her of stealing money from him and he assaulted her. Victim kicked the suspect and was able to flee the apartment. The male suspect was located and interviewed by Officers. He was later taken into custody for A&B & CSC 4th Degree. The incident was forwarded to the OCPO for review.

Special Attention: Larceny from Vehicles
How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you do not have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

On 03/08/2023, Officer was on routine patrol near Eight Mile Rd. and Evergreen Rd. when he observed a Black Chevrolet Impala with tinted windows and the driver operating a cellphone. The license plate was covered by a tinted plate cover and the plate returned with no insurance. The vehicle was stopped w/o incident and the driver was advised why he was stopped. The driver was the only occupant of the vehicle and is the registered owner. He did not have proof of insurance on him, and he tried to bring it up on his computer but was not able to. The driver was advised that the vehicle was going to be impounded due to not having proof of valid insurance. The driver advised that nothing illegal was in the vehicle, which included any guns or narcotics when asked. Officer was conducting an inventory search of the vehicle while waiting for Towing Service and observed a black handgun underneath the driver seat. The handgun was loaded with one in the chamber. 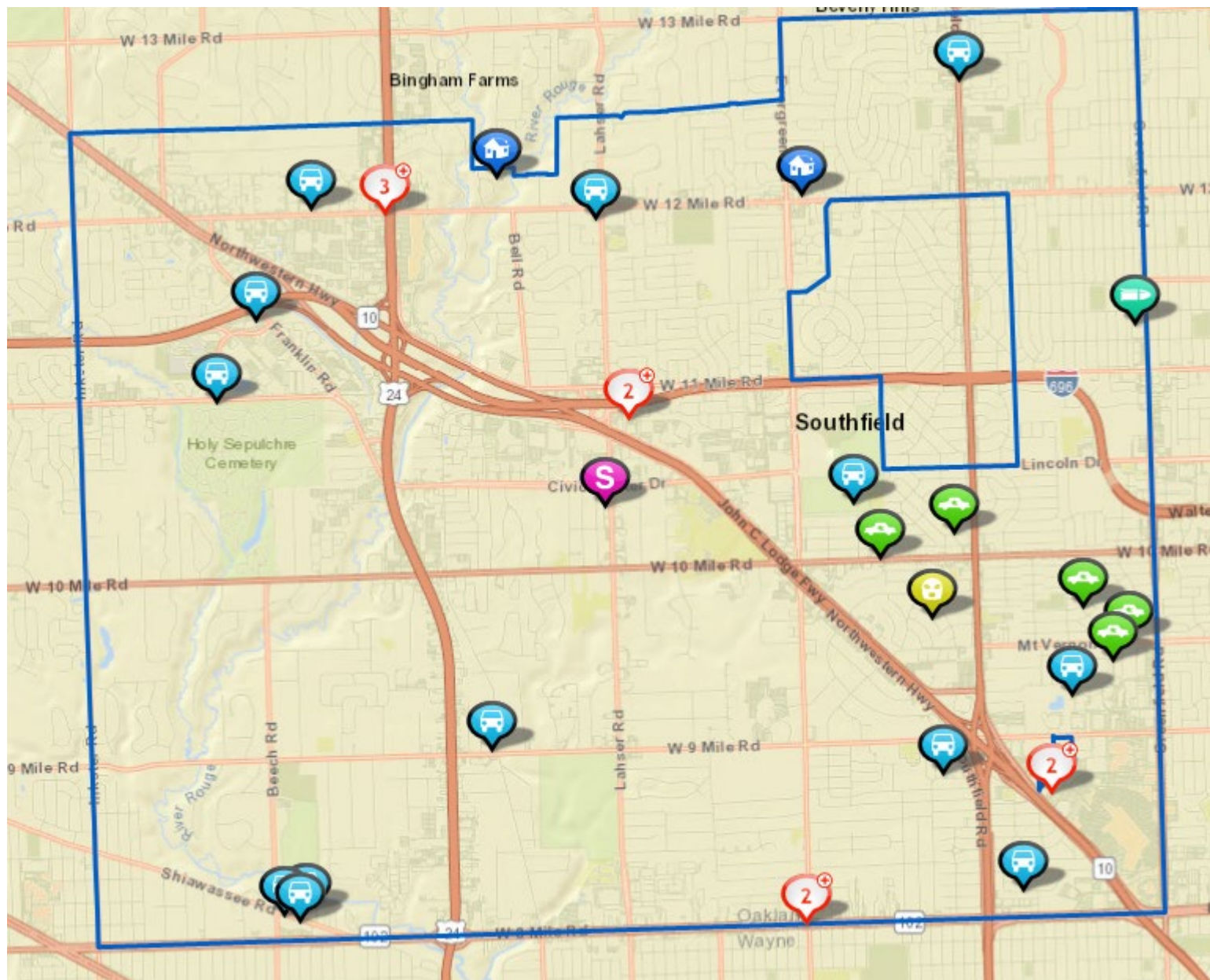
Larceny of Packages that were ordered and delivered via Common Carrier.









How to prevent this from happening to you!
