



Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

27000 Block of Northwestern Hwy

Officers were driving through the parking lot in the 27000 Block of Northwestern Hwy. and observed a Silver Jeep Grand Cherokee. The license plate on the vehicle came back improper, so Officers ran the VIN# on the vehicle and the vehicle came back as stolen out of Warren. Officers left the parking lot and surveilled the vehicle from down the street. Additional officers arrived in the area and started surveillance on the vehicle.

A short time later Officer observed the vehicle being occupied by a B/M wearing a black sweater and black jeans. Southfield Officers drove up to the vehicle and placed their patrol vehicles (visible lights activated) around the Jeep. Officers called out to the driver of the vehicle to keep his hands up. After several commands to keep his hands up, the driver put his hands in the air. He was then given commands to open his car door with his left hand. The driver refused to open the car door and questioned officers many times. After several commands, the driver opened the car door and walked back to officers. 
