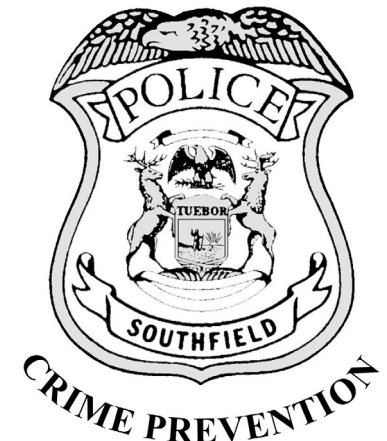
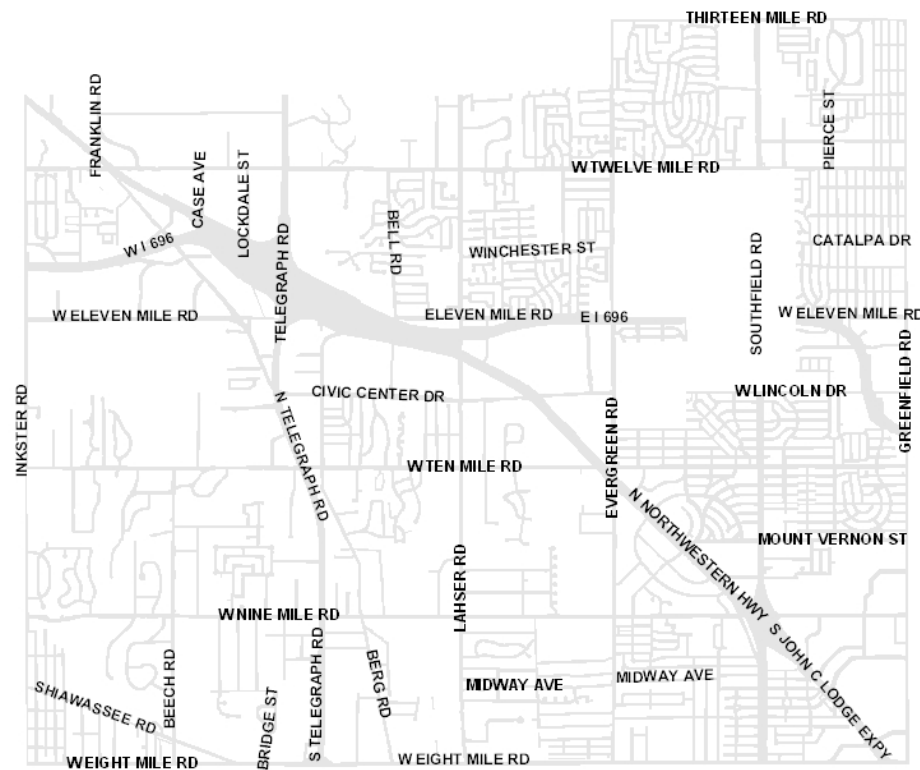

05/23/2023 3:30pm	23000 Riverside Dr. (Apartments)	Apartment door was kicked in.	Officers were dispatched to the 23000 Block of Riverside Dr. (Apartments) for a Home Invasion that just occurred. The R/P stated her ex-girlfriend arrived at her apartment, kicked in the front door, and left in a Light Blue Sedan. Further investigation revealed that the female R/P and female suspect have been dating for approx. 8 months. They do not live together but there are some belongings that belong to the suspect at victims' residence. (Residence later discovered to belong to victims' mother). R/P advises the two broke up yesterday. The ex-girlfriend came to the residence this date, kicked in the front door damaging the door frame, entered the residence and assaulted R/P numerous times. A Southfield Police Evidence Technician was on-scene and took photos of damage to the front door and R/P's injuries. R/P does not wish to prosecute but her mother wishes to prosecute suspect for the damages to her front door. Investigation is on-going.

Police arrived on scene and discovered forced entry through the main front door. The residence was ran-sacked and there was damage throughout the apartment. There were clothing shoes, and personal belongings that were tossed from the broken window on the second floor.</p> <p>Victim states that she and her ex-boyfriend had ended their 12-year relationship earlier in the week around Monday, 05/22/2023. Victim and Ex had been living together for the past 10 years. Victim just moved to this new location on 05/22/2023 with the children. The ex-boyfriend has only been to the location to pick up the children and take them to school.</p> <p>The ex-boyfriend has been sending threatening text messages and has made threats against the whole family via Facebook. Investigation is on-going.</p>

05/28/2023 11:35pm	16000 Oxley Rd.	Entry was through unlocked door.	<p>Victim states her ex-boyfriend came to her apartment this evening un-announced wanting to retrieve some items. They share a child in common who was not at the apartment. Victim allows her ex-boyfriend to come to her apartment to visit their child on occasion. The ex-boyfriend entered victim's apartment through an unlocked door. He started walking around the apartment and went into victim's bedroom looking for something under the bed. It is unknown if he retrieved any items from the apartment. They had a verbal argument while he was in the apartment. No assault occurred only a verbal argument. As the ex-boyfriend left out the apartment victim began to close the door behind him, but he kicked the door causing significant damage to the door and frame. When the suspect kicked the door a nail from the door frame cut victim's hand.</p> <p>A Southfield Police Evidence Technician made the scene and captured several photos of the damages and victims' injuries. The suspect left the area in an unknown direction in a Gray Ford Escape. There is an unserved PPO against the suspect with the victim as the protected person.</p> <p>The case was submitted to OCPO for review.</p>

Possibly arrived and left the scene in an Unknown Dark Colored SUV.

Victim states he was getting gas in the 24000 Block of Northwestern (Gas Station). He had just finished filling his vehicle when an unknown B/F entered his passenger side of vehicle and asked for a ride. After declining to give the female a ride she stated something about taking the vehicle and pepper sprayed him in the face. Victim exited his vehicle, and the suspect came around to the driver's side of vehicle and pepper sprayed him again. Victim ran into the gas station and asked the clerk to call 911. Officers arrived on scene and life support was called to treat victim. Officers looked at the camera footage from the incident at Speedway which revealed that the suspect got into a Black Jeep Cherokee Trail Hawk with heavy window tint, black rims, bearing a Michigan License Plate and fled the location traveling northbound Evergreen. The vehicle is registered to two persons that live in Southfield. One of the owners possibly matches the description of the suspect. Auto Theft Task Force assisted with the investigation of this case. Officers discovered that the suspected owner had been ran by Troy Police Dispatch earlier in the morning on the date of this incident when she had called into 911 asking for help and claiming something to the effect of someone following her or wanting to

		<p>hurt her. Due to this information, coupled with the odd carjacking attempt in Southfield when she had brought her own vehicle to the scene, Officers believed this incident may involve some sort of mental health crisis.</p> <p>Officers went to the suspects residence in Southfield. The suspect vehicle was not at the location. Contact was made with (2<sup>nd</sup> person registered to suspect vehicle)</p> <p>Information was obtained that the suspect, has been acting strange and paranoid lately and was talking about people trying to find her or hurt her and kept rambling on about conspiracies. She was so concerned about suspects mental state that she called her primary care physician earlier on today's date to get her in to see a mental health professional. She stated that this is not common for her and that she believes she is suffering from a mental breakdown.</p> <p>The other owner assisted officers with tracking locations where it was believed suspect might be. Officers did not locate her though.</p> <p>At one point owner#2 was able to make phone contact with suspect and was speaking with her over the speaker phone. Suspect was claiming that she was near the water and began saying "Goodbye" and that "it was over". Suspect was making comments about going into the water. It was apparent that the suspect was becoming suicidal. Officers were able to come up with a general location where the suspect was and</p>

		<p>several officers from the Auto Theft Task Force and local department officers began searching the shoreline of Lake St Clair near Lakeshore Dr. Suspects Black Jeep Cherokee was located in the roadway near the 5000 Block of Lakeshore Dr in Grosse Pointe Shores parked on an angle facing towards the water and blocking the curb lane of n/b travel. The vehicle was unoccupied. Officers continued to search the area and located suspect wandering in traffic nearby.</p> <p>The suspect was interviewed and made statements indicative that she was suffering from some type of mental illness. She made admissions to pepper spraying the victim in Southfield and was going to take his car because hers was not running very well because she had put dirt in her gas tank.</p> <p>As officers were walking suspect to their cars she began running towards Lake St. Clair. Officer attempted to grab onto suspect, but she slipped out of her hoody and jumped into Lake St. Clair. Several officers rescued her from the water and pulled her up to safety. She was handcuffed and taken into protective custody. Suspect and her friend (second owner of the suspect vehicle) were transported to nearby hospital where she again attempted to flee on foot from police while still in handcuffs. Victim states she was sitting in her vehicle (Black Chrysler 300) getting ready to check on her clients of whom she rents to at the 28000 Block of Everett St. A female (who is a former friend) and her husband drove a Red Dodge Challenger up behind victim, got out, and began approaching her. The female opened victim's car door and started punching her. Victim got out of her vehicle and started fighting with her female friend while her purse was slung around herself. The female suspects then pulled out a handgun and hit victim in the head with it. The male suspect then grabbed victim, threw her to the ground, and held her down. The female suspects then took victim's purse and the two suspects fled in the Red Challenger and drove off. Victim came into the front desk to report CSC IV. Victim advised she was inside the business located in the 28000 Block of Telegraph Rd. on 05/23/2023 at approx. 4:00pm. Victim was in the toothpaste and mouthwash aisle of the store when a black male subject grabbed and squeezed her buttock. Victim immediately turned around and yelled, "excuse me?", to the male. The male turned, ran down the aisle and out of the exit door to business. Victim described the male as being approx. 5'-10", mid-twenties, wearing tan shorts and a black shirt. The male was well groomed with a short afro hair style. Management at the store advised they will look to see if they have video of incident after victim makes a police report. Investigation is on-going.

### **DWLS/ Possession of Cocaine/ Possession of Heroin- 2- Arrests**

#### **W Twelve Mile Rd. & Northwestern Hwy.**

On 05/23/2023 Officer was on patrol in area of Northwestern Service Drive and Northwestern Highway. Officer observed a Gray Acura traveling NB on Northwestern Highway at Northwestern Service Drive. Officer ran the plate through LEIN and observed it returned on a Pontiac Grand Am. (Improper) After observing the vehicle, it appeared to be trying to avoid Officer. The vehicle was stopped in the 28000 Block of Northwestern Highway.

During the stop it was apparent that the male driver and female passenger were both very nervous. The driver advised he did not have a driver's license. It was later confirmed to be suspended.

After returning to his police vehicle Officer observed furtive movement by the driver. It appeared that he was reaching under the front seat. Officers returned to the vehicle and requested that both occupants exit the vehicle. The driver consented to a search of the vehicle. Officer looked under the driver's seat where he observed the driver reaching. He observed numerous articles of drug paraphernalia. He also located a clear zip-lock bag. Inside the bag was a piece of paper folded up. The driver made admissions that it was Heroin. At this time, the driver was taken into custody for DWLS and Possession of Heroin.

A second officer went through the passenger side of the vehicle and located suspected heroin inside a makeup bag where the passenger was sitting. The passenger was taken into custody for Possession of Heroin. Once the passenger was handcuffed, she advised Officers she had crack cocaine in her pants. She removed the small glass container from the back of her pants. Inside the container were two small crack rocks white in color. The passenger stated the driver told her to put it in her pants.

A Southfield Police Evidence Technician Field Tested suspected substances: One tested positive for possible presence of Heroin and one tested positive for possible presence of Cocaine. Both suspects were conveyed to the Southfield Jail, processed, and lodged.

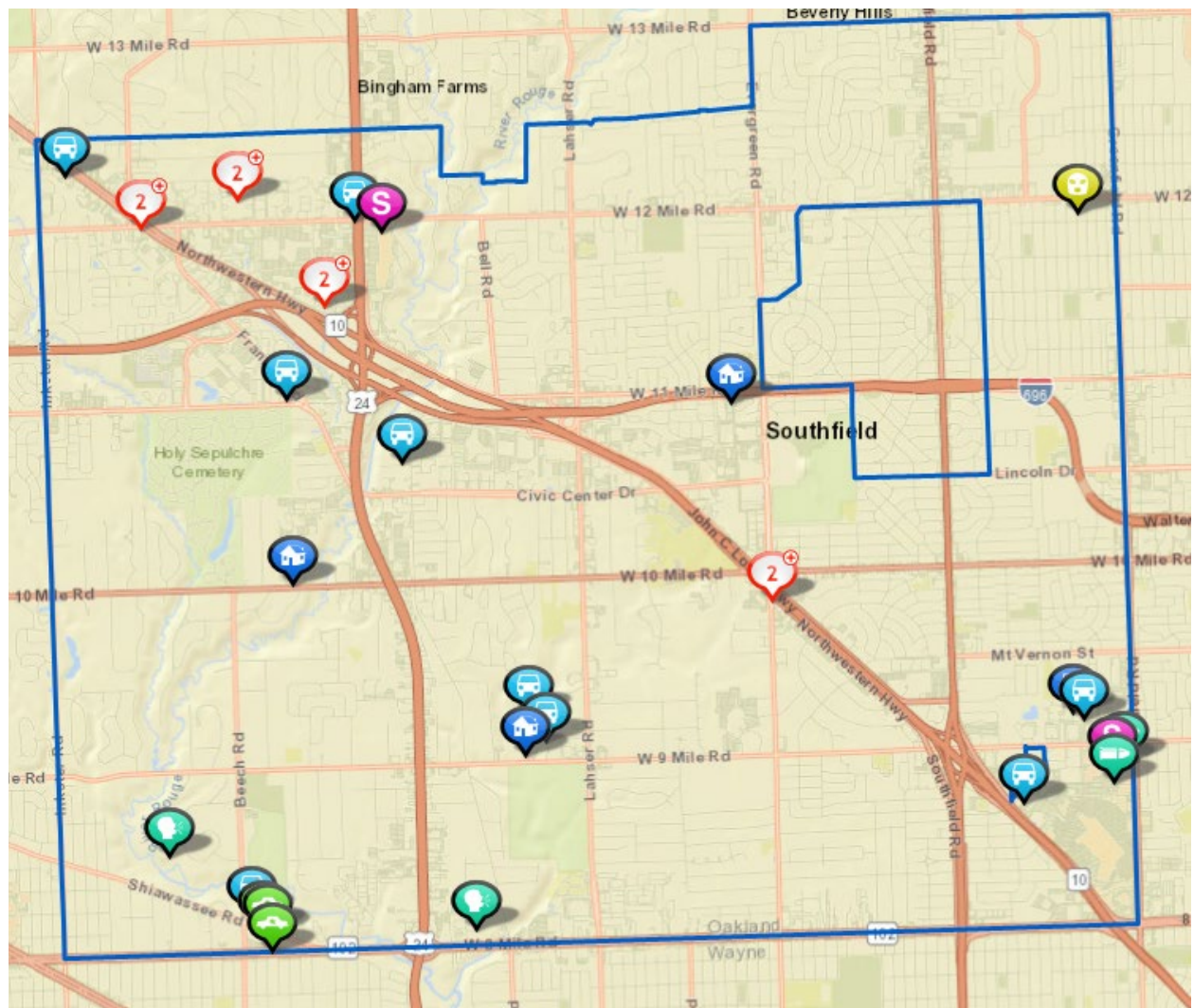
**Home Invasion/ A&B- 1- Arrest**









**25000 Block of W Ten Mile Rd.**

Several Southfield Officers responded to the 25000 Block of W Ten Mile Road for an Assault/Home Invasion in progress.

Officers arrived on scene, separated everyone, and identified a female that had entered the residence w/o any announcement and began assaulting the male resident. The two had recently broke up and the female became aggressive and started to punch the male numerous times. The male did nothing to the female he just covered up trying not to get hit. At some point the male grabbed the female to keep her from hitting him and she bit him in the arm. The male held onto the female until police arrived on scene and he let her go. The male did not want to prosecute and refused treatment and photos of his injuries.
