

A Southfield Police K-9 Unit responded to the scene. Officers entered the building and began a floor-by-floor search. On the 8th floor K-9 began hitting on the bathroom door. Officers entered the bathroom and observed 2 subjects hiding in the last bathroom stall. Both subjects were ordered out of the stall, and they complied. Officers secured two juvenile suspects. Officers continued to search the building and no other suspects were located. Officers did locate fresh red spray paint graffiti on the 9th floor. Officers checked one of the suspects hands and observed red paint splatter on his fingers. A Southfield police Evidence Technician responded to the scene and photographed suspects hands, the broken glass, and the graffiti inside the building. They also located a can of red spray paint that was taken as evidence. Officers located the suspects bikes nearby in the woods. The Property Manager responded to the scene and advised they want to prosecute. |

On 05/30/2023 at 5:33pm, Officers located a stolen vehicle (Silver Hyundai Elantra) parked in the 19000 block of Jeanette St. The vehicle was a confirmed stolen out of Southfield on 05/29/2023 without keys. Several Southfield Units & members from Auto Theft Unit came into the area and formed a perimeter around the stolen vehicle. One of the Auto Theft Units was able to determine that the vehicle was occupied by four subjects. Shortly after this Southfield and Auto Theft Units moved in on the vehicle with lights and siren activated and boxed the vehicle in to prevent it from fleeing. Three occupants were immediately secured while officers continued their investigation. One suspect bailed from the passenger side of the vehicle and fled on foot. Several Officers pursued the suspect through the neighborhood eventually following the suspect over the fence onto the Evergreen Hills Golf Course. The suspect was given numerous commands to stop but he disregarded officers. The suspect was followed into a pond on the golf course. He was given verbal commands to exit the water to which he complied. He was taken into custody and transported to the Southfield Jail where he was processed and lodged without incident. The driver of the vehicle was charged with R&C Motor Vehicle, the suspect that fled from Officers was charged with R&O. The other two passengers (juveniles) were released to their parents. Note: The recovered stolen vehicle had a punched and damaged ignition which is consistent with the recent thefts of Kia and Hyundai

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but do not leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you do not have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and

Officer was on routine patrol around Civic Center & Evergreen Rd. when he observed subject driving w/o his seat belt on and there was no visible license plate attached to the vehicle. There was a Temp Tag on the vehicle, but it was not readable.

Officer attempted to stop the vehicle in the parking lot in the 27000 Block of Evergreen Rd. The vehicle stopped and moved a couple times before it stopped completely. As Officer was walking up to the vehicle, he observed the driver of the vehicle reaching on the passenger side. He then observed the driver of the vehicle reach into the backseat behind the front passenger seat. Officer gave the driver a verbal order to stop moving in the vehicle. As Officer contacted the driver, he observed he was extremely nervous, shaking and sweating. Officer asked the driver for his driver's license. The driver stated he did not have one. The driver did produce a valid MI ID.

Officer asked the driver if he had anything inside the vehicle he should not have, and the driver advised there was a firearm in the car. The driver stated he had a pistol on him, and he threw it into the back of the vehicle. He went on to say he was nervous because he knew he was not supposed to have it on him while driving due to not having a CPL. While speaking with driver Officer observed the firearm on the floorboard in the backseat behind the passenger seat. The driver was instructed to keep his hands on the wheel of the vehicle.

Once other officers arrived on scene the driver was instructed to exit the vehicle. He was taken into custody w/o incident. The handgun was recovered along with the magazine and ammo. The driver was charged with CCW & DWLS II.

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Officers responded to an Armed Robbery that just occurred in the 20000 Block of Charlton Sq. (Apartment Building)

A B/M wearing jeans and a zip-up robbed a pizza delivery person and fled on foot. The victim was identified as an employee of Pizza Business in the City of Southfield.

Victim advised she was supposed to be making her delivery to the 20000 Block of Charlton. When she arrived at the location, she hit the buzzer for the designated apartment but failed to contact anyone. Victim called the phone# for the person that placed the order. The male answered and said he would be right down. A few moments later a male opened the door with cash in his hand. He asked victim if she had change for a \$100.00. Victim told suspect no. The male asked if they accepted CashApp and she said no. The male then handed victim cash amount close to the amount owed to pay for the order. When victim went in her bag to get change for the male, she looked back up and saw he had a handgun pointed at her. The male told her to give him everything. Victim told suspect she needed her ID and cards out of her wallet. The male told her he did not care and tried to grab her bag off her neck. He was unsuccessful and he reached into her purse and grabbed an undisclosed amount of cash along with her wallet. The male then ran back inside the apartment building in an unknown direction. Victim ran back to her vehicle and called 911. Victim described the suspect as a tall light skinned black male between 6'3 and 6'5. Victim stated he had short hair with dreads and was wearing a yellow zip up sweater with unknown-colored jeans and orange/blue/white Jordan shoes. Victim described the weapon the

Taken in the robbery were a medium pizza, 1 brownie, and cheesy garlic bread. Victim stated the male also took her wallet which included her ID, and several credit/debit cards. The male also took some cash which belonged to the Pizza Business and the Pizza Business delivery bag that was holding the food he ordered.

Southfield Police Detectives arrived on scene and started to investigate the phone# that was used to call in the order. The phone # was traced to a person that officers were familiar with, and he matched the description of the suspect. Officers were also able to come up with an address for the suspect in the apartment building he fled into. Detectives put together a Photo Show with suspect included.

The photo lineup was presented to the victim. She immediately picked out the suspect.

After officers left the area Detectives set up surveillance near suspects apartment building. A short time later Detectives observed suspect get into the back seat of a White Kia SUV. Officers stopped the vehicle at the entrance of the complex and initiated a felony stop. The suspect was in the backseat of the vehicle. He was taken into custody for Armed Robbery. The two passengers were released on scene. Cash was found on the suspects person. He was not wearing any of the

Cash was found on the suspects person. He was not wearing any of the clothing that was worn during the Robbery.

Detectives completed & obtained Search Warrant for suspects residence. (Apartment building that he fled into after the Robbery.) SEARCH WARRANT: Officers & Special Entry Team executed a search warrant on a residence in the 20000 Block of Charlton Sq.

When Officers executed the search warrant there was no response. Forced entry had to be made into the apartment. No one was located inside the apartment. Officers searched the interior of the apartment for evidence. Officers located all the pizza items that were taken from the victim in the Robbery. The food had been partially eaten. Officers also located victims credit cards and driver's license.



On 05/30/2023, Southfield Dispatch received a phone call from Security at Apartment Complex in the 27000 Block of Franklin Rd. Security advised that several residents reported that their vehicles were broken into, and items were stolen. Security advised that they reviewed surveillance footage and witnessed the suspect committing several larcenies from autos. Surveillance footage also shows the suspect entering a specific apartment after the incidents take place. Auto Theft Task Force made the scene and met with security who allowed them to review surveillance footage.

On 05/30/2023 at approx. 4:05am an unknown suspect is seen in the parking lot of the apartment Complex pulling on the door handles and entering several different vehicles. The suspect is seen removing items from the vehicles and later placing them into a Gray 2010 Ford Escape with a Michigan license plate. After the incidents, the suspect is seen entering the building and entering specific apartment. The suspect was described as a black male, short dreads / braids, white tank top, gray jacket, black pants with the letter 'N' on the right leg and a white patch on the left leg, and white shoes.

Officers made contact at apartment and spoke to a female who stated that her boyfriend was also inside the apartment, sleeping. Detectives witnessed a black male sleeping in the bed who looked identical to the suspect in the surveillance footage. He was taken into custody and his identity was confirmed. Suspect stated that his girlfriend and him share a Gray 2010 Ford Escape that is registered to his girlfriend mother. The suspect was taken into custody for Larceny from Auto. Three victims were located that had property taken from their vehicles. They later provided written statements.
