



On 11/14/2022, Officers were dispatched to the 23000 Block of Philip Drive with the report of an attempted Home Invasion, which just occurred. The suspect attempted to gain entry to the front door and ran away when she turned the porch light on. Officers checked the area, and the suspect was not located. R/P described the suspect as an unknown male, thin build, 6'0"- 6'2", wearing baseball style jacket with black and white faces on it, black or dark blue pants, and a backpack that was light in color (possibly a child's backpack). There was evidence that the suspect attempted to pry the front door open.

			loudly. A second caller stated she heard a female yell
			"get off of me".
			Officers arrived on scene and contacted the female
			(victim) in the hallway of the apartment building. The
			female was visibly upset and was crying. She advised
			the male suspect left prior to officer's arrival. Victim
			was escorted back to her apartment to be
			interviewed. Officers observed fresh damage
			consistent with Home Invasion to the front door of
			victim's apartment. A Southfield Police Evidence
			Technician was dispatched to the scene for photos
			and processing. Victim stated she and her male friend
			were inside the apartment alone watching TV.
			Victims' ex-boyfriend & child's father arrived
			unannounced prior to the 911 call. He began knocking
			at the door. Victim told her ex-boyfriend through the
			door that he needed to leave. He refused and
			continued to bang on the door with his fist.
			He was yelling through the door and asking if she had
			another male inside the apartment. The suspect
			continued to bang on the door until he forced entry
			into victim's apartment. The suspect immediately
			began fighting with victims' male friend by the front
			door. The two fell to the ground and began to wrestle
			on the ground. Victim repeatedly told her ex-
			boyfriend he needed to leave. R/P began to defend
			her male and then the suspect turned his attention to

	her and wrapped her up, with both hands around her torso, picked her up and slammed her to the ground. She landed on her back. The assault then stopped, and the ex-boyfriend fled the scene in a Grey Jeep Cherokee. The male friend that was with R/P also fled the scene prior to Officers arrival. The female victim was uncooperative with officers and refused to give officers any information regarding the male that was with her that was assaulted. She also stated she didn't wish to prosecute her ex- boyfriend. There is one child in common in their relationship. The suspect doesn't live in her apartment. The suspect later turned himself in on 11/17/2022 1:18am at the front desk (SPD). He gave a statement and was taken into custody for Home Invasion/ Domestic Violence.

The door was pushed open by two B/M's wearing all black, face covers and both brandishing handguns. The taller of the two males told the females they were being robbed. The males started to go through the bags in the room and took both females cell phones. One of the victims attempted to fight back with the males and both females were "pistol whipped". The males were able to grab the victim's cash and two cell phones (belonging to both victims). The males then fled the room. One of the victims' phones was pinging at a nearby address. Officers located this phone. The phone appeared to be ran over several times by vehicles. The phone was returned to the victim. The other victim's phone was last pinging somewhere in Detroit.

On 11/19/2022 at approx. 11:32pm Officers were dispatched to Gas Station in the 25000 Block of Evergreen Rd for reports of a trouble with subject. The R/P was the gas station clerk, who stated he was having problems with two subjects inside the store that he thought were stealing items. Officers arrived on scene and stopped the suspect vehicle after it left the Gas Station.

The driver of the vehicle was an uber driver. The suspects, 1- male & 1- female were seated in the rear of the vehicle. Special Attention: Larceny from Vehicles How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage, you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately calls 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you! Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
