


Officers checked the residence, and nobody was found inside the home. Officers inspected the items left behind by the suspect. Inside were checkbooks and other miscellaneous items including jewelry. A Possible suspect has been developed in this incident and the investigation is on-going.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage, you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately calls 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the

Officers were dispatched to the area of the 21000 Block of 10 Mile Rd. (College Dorms) for a welfare check. R/P requested officers to check on the welfare of her 2-year-old daughter. R/P's child's father took their daughter from her home after a physical altercation with R/P's grandmother in Detroit. R/P also advised that the father took her purse with a handgun inside of it. R/P located the father and her daughter walking near the college campus. Officers responded to this area and observed the father walking on the sidewalk of N/B Northwestern Service Dr, just south of Civic Center Dr. He was carrying the daughter on his shoulders.

Officer called out to the father, and he kept walking. Officer drove his police vehicle closer to the father and hit his siren to get his attention. He was told to stop, and he complied.

On 11/07/2022 Officers were dispatched the 21000 Block of Wallace regarding a Domestic Violence. The first caller stated his child's mother was breaking into his house. Dispatch advised officers there is an extensive history at this address between male & female and the female was arrested last year for trespassing at the residence.

Officers arrived on scene and spoke to both parties involved in the incident. The female half had visible injuries to her neck.

Female advises she was at their other residence earlier in the day (23000 Block of Coventry Woods) gathering items and getting her son. They got into a verbal argument and male half refused to give female half any of her personal belongings. She left and went to the male half's other residence in the 21000 Block of Wallace to gather some of her belongings from this residence.

Note: Female half doesn't live here and doesn't have permission to go into the residence. She advised Officers she used the garage code to get into the garage where there is a key to get into the house. When the male half got there, he assaulted female half numerous times and at one point dragged her by her hair and locked her in a bedroom. There were clumps of hair supporting this. When the female threatened that she called the police he let her out of the bedroom. He took her cell phone from her and put it in his safe. He later took it out and threw it at her near the front door. There was a dent in the wall and drywall dust on the cell phone to support this as well. The male half stated when he got to his residence his garage door was open and the female half was at his residence with a U-Haul truck and was inside his residence. When he entered the house, the female half attacked him with a broom stick striking him. Both subjects were

arrested for Domestic Violence. Note: There has been a long history (16 Previous Domestic Runs) between the two arrestees.


