The RIE distribution as of July 1, 2023 was discussed. Retirement Program Director apologized for not having the calculation completed for review but did inform the Board that there are 33 new participants this year and eligible retirees will only receive approximately 7.78% of their maximum calculated replacement amount. The Board discussed the viability of the program going forward and asked the Retirement Program Director to request a history of the annual RIE Reserve Balance accumulation from GRS.

## RESOLUTION

RE: <u>Diane Sue Townsel v. Lateef R. Townsel</u> Oakland County Circuit Court Case No. 22-515767-DM

**WHEREAS**, the Board of Trustees is in receipt of an Eligible Domestic Relations Order dated August 8, 2023, wherein Diane Sue Townsel, the Alternate Payee, is awarded certain rights to the benefits of Lateef R. Townsel, the Participant, and

**WHEREAS**, the Alternate Payee is entitled to claim a portion of the Participant's retirement benefit from both the defined benefit plan and the defined contribution plan, and

WHEREAS, the payments from the plan to the Alternate Payee shall begin when the Participant commences benefits or when the Alternate Payee elects to receive benefits at any time allowed by the Plan but not later than when the Participant commences benefits, and

**WHEREAS**, the Board's policy is to require that the costs for the actuary's calculations are to be borne by the parties to the domestic relations proceedings, and the order provides that the Participant and the Alternate Payee shall be equally responsible for any and all additional costs for actuarial services, and

WHEREAS, said matter had been discussed with legal counsel who has opined that the applicable terms of said court order are consistent with the provisions of the Retirement System and applicable law including Public Act 46 of 1991 (MCLA 38.1701) as amended, therefore be it

**RESOLVED**, that the Board acknowledges receipt of said court order, will pay pension benefits consistent with the provisions of the EDRO, and subject to an application by either the Participant or the Alternate Payee, and further

**RESOLVED**, that a copy of this resolution be immediately attached as the top sheet of the pension file and other appropriate records be kept for the Retirement System relative to this matter, and

**RESOLVED**, that copies of this resolution be sent to Lateef R. Townsel, the Participant; Diane Sue Townsel, the Alternate Payee; Krystin P. Recchia, Esq., attorney for the Alternate Payee; and the Board's actuary.

Duncan Megzor from Ares presented an update on Landmark Real Estate Fund VIII. He provided an overview of the firm, secondary market, and investment approach. Key statistics for Fund VIII were reviewed and questions from Trustees and Investment Consultant were answered.

Investment Consultant reviewed manager allocations and liquidity needs. No action was recommended.
