Investment Consultant presented the 1Q Performance Report. He discussed the poor performance from stocks and bonds during the quarter due to Fed policy changes, inflation, and the war in the Ukraine. The Fund was down 3.66% for the quarter and up 7.68% for the year; both results were ahead of the policy benchmark. He discussed the performance of the managers and noted the strong results from Walthausen, Reinhart, and LSV and weaker returns from WCM. He also noted the diversification benefits from the hedge fund and real estate allocations; both provided positive results this quarter. He distributed the April capital market summary and updated market values and noted the poor returns from all asset classes.

Legal Counsel reminded the Board that the Medical Director recently handled a non-duty disability application for Barbara Stewart who was examined by a physical medicine and rehabilitation doctor who determined that she was not mentally or physically totally disabled for duty in the employ of the City. Consequently, the SERS Retirement Board did not grant her disability retirement. Ms. Stewart has appealed that decision and has provided additional medical records. The recommendation of Legal Counsel is to have her reexamined by another doctor such as a neurologist or general practitioner who can assess the totality of her medical circumstances.
