


Surveillance Video shows a Black (2015-2017) Model Chevrolet Tahoe arrive and park in the back alley of the store. Three subjects emerged from the vehicle, wearing hoods, gloves, and masks. A 4th subject remained in the vehicle as the driver. The subjects cut the cable around the front door handles, and pried the front door gaining entry. The subjects then entered the store and took several items. Suspect Descriptions: -Suspect#1: young, male, 5'10" - 6', medium build, wearing: black hoodie/black pants/black shoes, white mask, white gloves - with yellow crowbar -Suspect#2: young, male, 5'10" - 6', medium build, wearing: red hoodie/gray sweatpants/dark gray shoes -Suspect#3: young, male, 5'10" - 6', medium build, wearing: gray hoodie/gray sweatpants/black shoes -All the suspects had hoods, masks, and gloves. -Suspect#4: No Description

Special Attention: Peeping Tom taken into Custody

On 07/29/2019 R/P observed a B/M looking in to her front bedroom window at 2:15am.

Victim reported that the suspect was a B/M wearing a black shirt and black pants with white flip flops. Victim caught the incident on her surveillance camera and provided a copy of the video to a Southfield Police Detective who was investigating the incident.

Detective viewed the video and observed a B/M who appears to be the same suspect who was previously convicted of peeping into windows last year (2018) and is currently still living in the area.

Similar Incident was reported as well on 08/01/2019 for the dates of the 26th through the 29th of July in this area.

Detective contacted suspect and set up a date for interview and he failed to show up or call.

The case was submitted to the City Attorney's Office for review and charges for Peeping Tom were authorized.

On 08/23/2019 Detectives and Officers went to the suspects residence in Southfield, located the suspect and he was taken into custody w/o incident for Peeping Tom.

He was later interviewed and after seeing the video

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.

Domestic F/A- 1- Arrest

Telegraph Rd. & W Twelve Mile Rd.

Officer was on routine patrol when he observed a Black Ford pursuing a Silver Honda at an excessive rate of speed on the Northwestern Service Dr. approaching Telegraph Rd.

In the intersection, the Silver Honda lost control and almost crashed into another vehicle that was stopped at the red light.

Officers attempted to stop both vehicles.

The Silver Honda stopped and the female occupant advised the male in the Ford is armed with a pistol and pointed it at her.

Officer caught up to the Black Ford and stopped it. Two males were detained while Officers investigated further.

Information was obtained by several witnesses in the Silver Honda identifying the driver of the Black Ford as pointing a black semi-auto handgun at them. 2- Handguns were recovered from the Black Ford. After interviewing everyone it was discovered that this incident was the result of a domestic situation. The driver of the Black Ford saw his wife getting out of the Silver Honda and she is having an affair with the male in that car. The suspect driving the Black Ford was taken into custody for Domestic F/A.

is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

On 08/21/2019, Officers were on routine patrol and observed a Gray Hyundai Tuscon traveling E/B Nine Mile from Greenfield. A Lein check on vehicle returned with no insurance through SOS. Officers attempted to stop the vehicle as it was pulling into a parking space in Apartment Complex. Officers stopped their patrol vehicle behind the vehicle. The vehicle then abruptly reversed and struck Officers patrol vehicle. Officer was standing outside of the patrol vehicle in the door jamb and was struck by the door. The driver then put the vehicle in drive and fled over the grass/walk way of the apartment complex and then onto W/B Nine Mile Rd. Officers pursued suspect vehicle into Detroit where Officers performed a pit- maneuver and disabled the vehicle. The suspect fled on foot and Officers lost sight of the suspect. The suspect was described as (B/M 20-30 slim build, short black haircut, white t shirt, and blue shorts).

A B/F that was observed by a witness exiting the suspect vehicle while Officers were attempting to locate the driver was later stopped and questioned. The female admitted to being a passenger in the vehicle but stated she didn't know who the driver was.

A search of the suspect vehicle by Officers, located a firearm on the floorboard in plain view where the female was sitting in the vehicle and another firearm under the driver's seat. Both firearms were reported as stolen. They were confiscated by Officers.

The female was taken into custody for CCW.

Further investigation by Officers and Southfield Detectives a suspect was developed.

A photo show was put together with suspect in the photo show. Separately, two witnesses positively identified suspect that was developed as the suspect that fled from them.

This incident will be submitted to OCPO for complaint & Warrant.

Officer was on routine patrol when he observed a Gold Chevy Malibu exit business onto Telegraph Rd. The vehicle didn't appear to have a license plate attached. Further inspection revealed that there was a license plate attached but there was a tinted license plate cover that obstructed the view of plate. After running the plate, it came back No Insurance through SOS. The vehicle was stopped by Officer w/o incident. During the traffic stop Officer who was assisting on the stop advised that there was furtive movement by the left rear passenger of the vehicle and he kept turning around looking at Officers when they were in their patrol vehicles.

After getting consent to search the vehicle, the left rear passenger was removed from the vehicle. Officers noted that this passenger was sweating, shaking and was very nervous. When Officers questioned him about this he made admissions that he had a handgun on his person and he stole it from his aunt. The handgun was recovered from subject's pants pocket. This passenger was taken into custody for CCW.

The female half was taken into custody for Disorderly Conduct. The prosecutor issued warrants on both parties for Disorderly Conduct. The male half turned himself in on a later date.
