


Special Attention: Shots Fired

01/01/2020 12:49am

29000 Block of Franklin Hills Dr.

(Apartment Complex)

On 01/01/2020, Officers were dispatched to Apartment Complex in the 29000 Block of Franklin Hills Dr. on a call of shots heard. After arriving in the complex Officers heard approx. ten shots. The shots appeared to be from a gun and really close to Officers location.

Further investigation Officers walked to the rear of the 29000 Block of Franklin Hills Dr. and observed a young B/F (Age 14) wearing a burgundy shirt with an afro holding a rifle in the air. The rifle was later identified as .22 Cal. Rifle. The female was ordered to put the gun down and she complied. Officers took possession of the rifle and made it safe. In the process of doing this Officers observed several more guns just inside the apartment near the sliding door. Officers secured all the occupants and collected all the firearms.

Officers contacted the juvenile's mother who was on scene. The mother stated she gave her daughter permission to shoot the gun into the air? Child Protective Services (CPS) was contacted regarding the matter and all the firearms were confiscated and taken as evidence & safe keeping. Incident is under further investigation.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Officers responded to a report of a stabbing in the 26000 Block of Stanford Dr. R/P stating a woman was bleeding from her back and she was walking towards 11 Mile Rd.

Officers located the female on Summerdale near Eleven Mile Rd. They confirmed she had been stabbed in the back. A Life Unit was called to scene to treat victim.

Victim stated that she was having an argument with her boyfriend. They started arguing and he knocked her down, assaulted her several times and she fell on top of a table braking two glasses. Suspect then took a piece of the broken glass and stabbed her in the back with it. Suspects mother and a friend who were present during the incident were uncooperative with Officers when questioned about what happened. The suspect wasn't located on this date. Officers contacted the suspect and he was taken into custody w/o incident. He was taken into custody for DWLS & Domestic F/A. Suspect has a prior conviction for Domestic Assault.

On 01/02/2020 Officers were dispatched to the 25000 Block of Orchard Grove St. regarding a Domestic Assault just occurred. Information was given to Officers that the R/P (female) and her boyfriend got into an argument and he assaulted her.

The boyfriend took the R/P's cellphone and left the area in a Beige Lincoln Town-Car.

Officer arrived in the area and located suspect vehicle parked and running close to the residence. Officers contacted the driver of the vehicle. Officer identified the driver as the male half of domestic and questioned him about what happened between him and the female half. He stated they got into a verbal argument over trust issues. He made admissions that he took her phone and threw it onto the freeway over I-696. Officers located the phone in subject's car under the front seat. Subject was asked why he lied about the phone and he stated, "I bought the phone, I can do what I want with it". He took her phone so he could read her text messages.

The female victim stated he took the phone from her when she was trying to call 911. Further investigation led to the arrest of male suspect for Domestic F/A with a Motor Vehicle.

Retail Fraud/ MDOP to Display Case- 1- Arrest

(Commercial- Home Goods & Grocery)

On 01/04/2020 at 2:39pm, Officers were dispatched to business in the 22000 Block of Eight Mile Rd. to a possible Retail Fraud in progress which was reported by Officer who was working a detail at the business. Officer advised over the radio that a subject was observed by staff concealing merchandise from the Optometry Section of the store. The suspect was still in the store. Officer put out a detailed description of the suspect. W/M approximately 30 Y/O, short scruffy beard, wearing a thin black leather jacket, and a brown hat.

Officers arrived at the business and began searching the store for the suspect. Officers located the suspect near the central grocery section of the store. Officers contacted the suspect and advised him they wanted to talk to him. The subject began taking steps backwards away from Officers and was uncooperative. After multiple requests to put his hands behind his back the subject complied and he was secured so Officers could complete their investigation.

During the pat-down of subject Officers observed a large bulge in the suspects waist line and suspected he may have a weapon.

The subject consented to further search of his person.

Suspect was taken into custody for Retail Fraud & MDOP.
