

On 02/24/2021 at approx. 5:45pm, Officer was on routine patrol when he observed a Silver Ford Focus travelling W/B Eight Mile just west of Evergreen occupied by two subjects.

Officer ran the license plate that was attached to the vehicle. The Ford Focus returned as a stolen vehicle out of Detroit taken on 02/16/2021. Officer waited for other units to assist before attempting to stop the vehicle.

Officers attempted to stop the vehicle. The suspect disregarded Officers emergency lights and sirens and fled W/B Eight Mile. Officers engaged in a short pursuit of the stolen vehicle. During the pursuit, the suspect vehicle struck one of the Officers vehicle. The suspect continued to flee W/B Eight Mile where he attempted to enter a turn-around at Bridge Street for E/B Eight Mile. The suspect was unable to brake in time and spun his vehicle around in the turn around until he came to a stop facing E/B on the median of the turn-around. Officer used his patrol vehicle to pin the suspect vehicle in. When Officer pinned in the suspect vehicle, two occupants exited the passenger side of the vehicle and ran south across Eight Mile Rd. One of the suspects, RF passenger was observed by Officers carrying a tan handgun in his right hand while fleeing on foot.

Officers pursued the driver and took him into custody after a short foot pursuit. Additional Officers pursued the passenger and eventually caught up with him and took him into custody. Officers did not locate a handgun on this suspect when he was

Victim states she was at her vehicle getting ready to leave work. Her ex-boyfriend confronted her, took her keys and phone, forced her into the passenger seat, and assaulted her. He "punched" her in the face and arms multiple times, entered the vehicle and drove away.

The suspect drove to his house in another jurisdiction and would not allow victim to get out of the car.

Once they got to the suspects house he still would not let victim get out of the car until she agreed that they "were back together".

The suspect took victims cell phone and made statements that he was going to keep here there until she said he was his girl." Victim advised she said "Alright, I'm your girl". The suspect then got out of the car and entered his home.

Victim got into the driver's seat of her vehicle and took off. After this incident victim states around 9:00pm the suspect came to her house, also in another jurisdiction and was banging on her windows and doors. After calling the Police the suspect ran to a Burgundy Buick and got into the passenger side of the vehicle and fled the area.

The suspect has threatened victim in the past when they broke up in 2019. He made threats to harm her and her family back then.

Detectives reviewed surveillance video from business where abduction occurred and confirmed that the female was forced into her vehicle and abducted.

arrested. Officers searched the area near the suspect's arrest location on the east side of the apartment building. After a short search, Officers located a tan colored handgun near the fence line under some trees/shrubs. This handgun matched the one that officers observed suspect carrying when he ran from the stolen vehicle. The handgun was loaded with one in the chamber. The case was forwarded to OCPO for Review. Warrants were secured for both suspects.

Suspect has been identified and Detectives have secured a warrant for suspects arrest.

Order conditions: Suspect is not to possess any weapons, which he was found to be in direct violation of this order.

Injunctive Order #2

Order Conditions: Suspect is not to drive unless validly licensed and insured, both of which he was not at the time of the stop. The driver was taken into custody for CCW, DWLS, and 2- counts of Violation of a Preliminary Injunctive Order.

Officers arrived in the area, located the vehicle and detained male & female that were inside the vehicle. Officers located a handgun in the female's coat pocket.

After interviewing both subjects and witnesses both subjects were taken into custody. It was reported that the male physically assaulted the female while she was seated in the vehicle. It was also reported when the female got out of the car and was walking away the male started to follow her in the vehicle. The female fired one round in unknown direction. The male was not injured.

A Southfield Police Evidence Technician processed the scene and collected evidence.

reported that the victim & suspect were observed fighting and
then they heard a gunshot. Officers recovered a handgun from
the suspect's vehicle. A second person that witnesses stated
was involved in the shooting was taken into custody by Officers
later in the evening. Investigation is on-going.
