



Special Attention: Auto Thefts 2- Arrests were made of subjects believed to be involved in recent thefts of Chargers & Challenger Hellcats & Scat Packs. 02/10/2020 2:51pm 26000 Block of Evergreen Rd. (Office Complex- Parking Structure) Officers were dispatched on Auto Theft in progress at parking structure connected to Office Complex in the 26000 Block of Evergreen Rd. Two Suspects were observed breaking out the rear window of a White Dodge Charger Hellcat and driving it away. (The suspect vehicle was a White Chevy Equinox occupied by 3- B/M's) Southfield Officers were travelling through a nearby parking lot, when they observed a White Charger with a Black Stripe travelling N/B Central Park Dr. matching the description of the vehicle that was taken. Officers activated their lights and siren to catch up to the suspect vehicle. The suspect vehicle sped up to get away from officers. The suspect vehicle turned E/B on 11 Mile Rd. towards Evergreen Rd. As Officers were catching up to suspect vehicle, the White Dodge Charger disregarded the red light at 11 Mile Rd. and Evergreen Rd. and was struck by a civilian vehicle, traveling S/B on Evergreen Rd. driver's side disabling the stolen vehicle. Both suspects had to exit from the passenger side of the stolen vehicle and fled on foot. One of the suspects stopped and returned to the vehicle briefly and retrieved their Pro Pad Tablet that was used to start the stolen vehicle. Both suspects fled into nearby residential neighborhood.

Officers set up a perimeter and located one of the suspects B/M wearing a red hoodie and red sweat pants run out from behind a residence in the 19000 Block of Middlesex Ave. Officers gave out loud verbal commands to the suspect to stop and get on the ground. The suspect complied and he was taken into custody w/o incident.

Additional Officers responded to the area where suspects fled. Officers observed the second suspect, a B/M wearing all grey running W/B in front of houses on the north side of Coral Gables. Officers were chasing suspect on foot. The B/M continued running W/B toward Evergreen Rd. A Southfield Police K-9 Officer ordered the suspect verbally to stop fleeing or he would be bit by his Police K-9. The suspect ignored the K-9 Officer and continued fleeing on foot. Because the suspect was a fleeing unsearched felon that was continuing to actively resist his capture, K-9 Officer gave his K-9 the apprehension command. The K-9 caught up to the suspect and made a physical apprehension on the suspect biting him on his left bicep. The K-9 was immediately called back and the suspect was taken into custody w/o any further incident.

Disorderly Conduct- 1- Arrest 02/05/2020 10:38pm

18000 Block of W Twelve Mile Rd.

On 02/05/2020, Officers were dispatched to the 18000 Block of W Twelve Mile Rd., reference a trouble with subject. Dispatch had advised that the male half of a verbal domestic had returned and was threatening to have additional subjects come to location to do the female caller harm.

Officers had been to the same residence earlier in the evening regarding an argument between the male & female. At that time, the male was given a citizen assist, transport to 7 Mile and Greenfield, after Officers determined it was a verbal argument only. Upon arrival, Officers observed a male subject hitting the window of a 1st floor-level apartment with both hands repeatedly. While he was hitting the glass, he was yelling unintelligible things in a loud voice. The individual was identified as the same male subject that was driven to 7 Mile & Greenfield earlier in the day. There was a strong odor of intoxicants coming from the subject and he was taken into custody for Disorderly Person. K-9 then conducted an article search for the instrument that was used to start the stolen vehicle. They located the Pro Pad Tablet, (Key Programmer) that the suspect went back to the stolen car to retrieve. The Pro Pad was used to start the stolen car. (Plugs into cars computer system and overrides the ignition system)

Several Charger & Challenger Hellcats and Scat Packs have been taken using this type of device recently.

Domestic Assault/ F/A with Motor Vehicle - 2- Arrests 02/06/2020 8:31pm 21000 Block of Dartmouth Dr.

Officers were dispatched to a Domestic Situation in the 21000 Block of Dartmouth. The female half was at the Grandfathers residence to pick up her runaway daughter. While Officers were in route the daughter phoned police and advised that she had left the residence with her Grandfather and her mother was chasing them and ramming into his car. The Grandfather's car was eventually disabled from being rammed and the mother attempted to remove her daughter from the car even though she didn't want to go with her mother.

The Grandfather assaulted the mother and held her down until Police arrived on scene.

Officers interviewed parties involved and witnesses.

The Grandfather was arrested for Domestic Assault and the mother was arrested for F/A with a Motor Vehicle.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizens can also schedule the package to be picked up by themselves at the common carrier facility.	Domestic Assault- 1- Arrest 02/08/2020 5:29am 27000 Block of Northwestern Hwy.
