

16000 Block of W Nine Mile Rd.

(Hair Salon)

On 07/13/2020 Several Officers were dispatched to a possible kidnapping that occurred at 16000 W Nine Mile Rd.

R/P called police and stated her daughter had just been kidnapped. Dispatch received several more calls about gunshots being fired at the same location. Officers arrived on scene and were waved down by several witnesses in the parking lot.

The witnesses stated they saw two black males shooting AK-47 style rifles at a third black male running s/b through the parking lot. The witnesses stated after the black males finished shooting, they entered the backseat of a Chrysler 300 and the vehicle fled the scene. The witnesses stated the black male being shot at was wearing a white t-shirt and black pants and continued running eastbound on W Nine Mile Rd. (Matches desc. of suspect that took the child)

The R/P (mother) was located and interviewed. R/P stated she was in the process of doing females hair when her child's father (child in common) walked into the suite. He picked up their daughter in common who was with the mother at her work and attempted to take her. The father of child was also

Domestic F/A Investigation: 1- Arrest

07/15/2020 1:13am

18000 Block of W Nine Mile Rd.

Officers were dispatched to the 18000 Block of W Nine Mile Rd. for a report of a Domestic Felonious Assault. Victim stated her husband pulled a gun on her. Victim fled the residence and was waiting outside in front of a neighbor's house.

Officers arrived on scene and set up a perimeter around the house and interviewed the victim. Victim advised her husband had been drinking and they got into a verbal argument. Victim stated that her husband pointed a gun at her and fired one round over her head.

Officers eventually established contact with the male suspect and talked him out of the residence w/o incident. After getting permission to search the residence, Officers recovered a handgun in the basement. The serial # had been ground off the handgun.

Officers searched for evidence regarding victims claim that her husband fired one round over her head. No evidence of a spent shell casing or damage from a spent round was found. The male half was taken into custody for an outstanding Warrant out of Oakland County. He was transported to Oakland County Jail.

accompanied by his friend, an unknown black male. R/P stated that both of these men were armed. R/P attempted to retrieve her daughter but her husband refused.

R/P states the two females that had come into the salon earlier came out of the salon. The female that was getting her hair done slapped R/P in the face and assaulted her. The two males and two females all fled the building. R/P's husband fled with their child.

R/P attempted to follow them and as she got to the lobby she heard several gunshots.

Witnesses outside state there may have been two B/M's with AK-47 type weapons that were shooting at the two B/M's that left with the child.

Southfield Police Detectives and Evidence Technicians were summoned to the scene for processing and collecting evidence.

An amber alert was put out by MSP.

Later the same day the suspect and his child came into the station with his attorney and he was interviewed. The child was fine and unharmed. After interviewing suspect, it appears that he may have been set up by his ex-girlfriend, they knew he was coming and one of the shooters may be an associate of R/P's.

Currently there is nothing in the system (court) stating who has the right to the child.

Child Protective Services was contacted and it was decided that until this does go before the court the child will be returned to the mother.

Officer stopped vehicle after observing the driver swerving and hanging out the driver's door window. The vehicle was stopped and the driver was investigated for OUIN.

During the investigation, the suspect fled on foot shedding his clothing as he fled. Officers quickly set up a perimeter and a Southfield Police K-9 Unit responded to scene. The K-9 began tracking into the woods behind Southfield High School. During the track, the suspect was flushed out of the woods behind Southfield High School and he was taken into custody. A later search of the suspect's vehicle rendered two long guns in the passenger compartment and trunk of the vehicle. The suspect was charged with Operating Under the Influence of Narcotics and CCW.

This incident is under further investigation.

The R/P's 2018 Gray Dodge Charger was leaving the area as Officers arrived and tried to run Officers off the road. Officers began a pursuit of the vehicle which was terminated. A report was taken, vehicle was entered as a fleeing and eluding vehicle but not as a stolen as the R/P is not the registered owner. The R/P advises he sub leased the vehicle from a subject with the intentions of buying the vehicle. He had already given this subject a sum of money with no contract or documentation of the deal. Officers ran the plate and the vehicle ownership came back to a female who is an associate of the person that sub-leased the vehicle to victim. Officers attempted to contact the owner with negative results. Victim knows the owner and he believes that the owners associate scammed him on the sub leasing of the vehicle and he also believes this same subject was the one that took the vehicle.

07/18/2020 3:57am 25000 Block of Shiawassee Rd.

(Apartments)

On 07/18/2020, Officers were dispatched to the 25000 Block of Shiawassee Rd on a report of an armed subject. Dispatch advised an individual was shooting a gun from a Dark Colored Ford Fusion with a Michigan License Plate.

Officers arrived on scene and met with R/P.

R/P stated he arrived home from work and observed a Jeep with two females and two males standing near a Ford Fusion. They all appeared to be drinking. R/P observed the Jeep pull off and then the driver of the Ford Fusion ran inside the apartment building. Once the driver left the vehicle an unknown male passenger fired four rounds from a handgun into the air. The driver of the vehicle then returned and both males fled the area. R/P followed subjects and they were last seen e/b on 8 Mile Rd. near Lahser Rd. A Southfield Police Evidence Technician recovered Four (4) Spent Shell Casings from the area where suspect fired the rounds off.

Nobody was believed to be injured in the incident. The owner of the suspect vehicle has been identified and incident is under further investigation.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

This incident led to several males and females fighting. There were additional accusations that someone had a knife and made threats and someone had a gun and pointed it at someone.

One of the male suspect/victims displayed signs of mental illness. He was transported to the hospital for treatment and he was Petitioned for Commitment and Evaluation.

No one was seriously injured and incident is under further investigation.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
