


On July 28, 2021 at approx. 9:57am, Officer located a stolen Black Dodge Durango parked in the rear parking lot of Apartment Complex in the 23000 Block of Providence Dr. The vehicle was reported stolen out of Detroit on 03/04/2021.

Officer maintained surveillance on the unoccupied vehicle in the lot. At approx. 3:00pm a tall, skinny B/M wearing a black t-shirt, gray pants, and a black nylon full face ski mask was walking from the apartments toward the Durango. Officer believed this subject was attempting to hide his identity while entering the stolen vehicle by wearing a full-face ski mask. The subject entered the vehicle and drove out of the complex onto Providence Dr. Officer continued surveillance on the vehicle until other Officers attempted to stop the vehicle at Southfield Rd. North of 8 Mile Rd. The vehicle began fleeing from the traffic stop and was blocked by traffic in front of him. Officers pulled their fully marked patrol vehicles in front of the stolen Durango to prevent a pursuit. The stolen Durango quickly accelerated and deliberately rammed Officers patrol vehicles and pushed their vehicles out of the way. The vehicle began fleeing from Officers after the felonious assault with a motor vehicle.

During the pursuit, Officer disabled the vehicle with a P.I.T. maneuver. The suspect exited the vehicle and fled on foot from Officers. Officer deployed his taser which was effective in stopping the subject while he was in the rear yard of residence in the 19000 Block of Ashton. Additional Officers arrived and secured the suspect.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

The suspect still had the black nylon ski mask on that he was observed wearing earlier. Officers recovered a Generic Dodge Key Fob with no key attached to the fob from the front of suspects pants that was on a keychain.
