


Officers were dispatched to the 27000 Block of Northwestern Hwy (Hotel) for a report of a Felonious Assault.

Victim states his girlfriend showed up at the hotel and started banging on his hotel room door. She thought he was there with another woman. When victim wouldn't answer the door, his girlfriend went out into the parking lot and sliced two of the tires on his truck. When victim went outside his girlfriend tried to stab him with the knife.

Shortly after this the suspect got into her Green 2010 Chevrolet Traverse that was parked next to victim's truck reversed out of the parking spot and from approx. 20 feet away, accelerated at him and he had to side step out of the way. Suspect then used her vehicle to ram the rear of victim's truck pushing it forward, almost crashing into the building.

Further investigation led to the arrest of the passenger for Southfield Warrant, Unlawful Discharge of a Firearm.

During the search of this subject Officer located a magazine with 10-.45 cal. rounds in the subject's pocket. The subject stated the handgun was in the car, on the floor by the passenger seat where he was seated. Officer recovered the handgun and another magazine with 10 rounds from the vehicle. The subject did not have a CPL and he was also charged with CCW. Unknown if this handgun is related to the Unlawful Discharge Southfield Warrant.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Retail Fraud- 1- Arrest

(Home Goods)

TCSU Officers located and arrested a subject who was wanted for a Retail Fraud that occurred at Home Depot in Southfield on 07/02/2020. The suspect was lodged in the Southfield Jail.

Details:

On 7/2/2020 TCSU Officers were working surveillance in the parking lot of business in the 29000 Block of Southfield Road due to multiple Retail Frauds that had occurred over the past month. Officers observed w/m in his late 30s running from the store as if he committed a crime. Officers observed the suspect enter a Blue Chevy Trailblazer. The business called in a Retail Fraud that had just occurred. Officers obtained a license plate which registered to a 2007 Trailblazer out of Howell. Officers were unable to follow the driver due to his reckless driving while exiting the commercial complex. On 7/7/2020 TCSU Officers following up on this investigation located the suspect vehicle at a residence in Commerce. Officers contacted Oakland County Sheriff Units to assist with a traffic stop. A traffic stop was conducted by Oakland County Sheriff at Oakley Park and Commerce Road. Officers spoke to the driver and positively identified him as the person who committed the Retail Fraud on 7/2/2020. The subject was taken into custody for Retail Fraud 1st Degree.

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Details:



The suspect had attempted to run his wife over with his vehicle in Detroit and they have been hiding from him since.

Surveillance: On 07/09/2020 TCSU Officers set up surveillance at residence where suspect stays with an associate.

Officers located the suspects White Dodge Journey at the residence. At 5:18pm Officers observed a male exit the residence and enter the White Dodge Journey. The subject matched the physical description of the suspect. Officers followed the vehicle to a Gas Station in the 10000 Block of Seven Mile Rd. where the suspect was taken into custody w/o incident.

Southfield Detective swore to the Home Invasion Warrant and the suspect was arraigned as charged.
