


#### **Shots Fired**

#### (Apartments)

On 06/23/2020, Officers were dispatched to the 23000 Block of Providence Rd. (Apartments) for the report of shots fired.

The R/P stated he heard gun shots coming from outside followed by screaming.

Officers arrived on scene. Officers located a female in front of the building stating she was shot at. Victim stated she and her girlfriend were at her aunt's apartment when they got into an argument. Apparently over victim cheating on suspect.

Victim stated she was walking outside to get into her car when her girlfriend pulled up in the car.

Her girlfriend got out of the vehicle, pulled a gun out and pointed it her. Victim attempted to flee when her girlfriend shot twice at her.

Suspect got back into victim's car, a Black Envoy and left the area. Victim was not injured in the assault. One spent shell casing was recovered by Southfield Evidence Technician.

Suspect has been identified and incident is under investigation.

#### (Hotel)

On 06/22/2020 at 6:48pm, Officers were dispatched to hotel in the 28000 Block of Northwestern Hwy regarding a stolen vehicle reported out of DPD that was plotting through Sirius at that location.

Dispatch described the vehicle as a 2018 Blue Dodge Charger.

Dispatch also advised officers that per a LEIN return on the vehicle, it was taken in an Armed Robbery UDAA. (Car Jacking)

Officers arrived on scene and located the vehicle in the parking lot. It was occupied by two subjects. Officers blocked the vehicle in and ordered the male driver and female passenger from the vehicle. Both occupants were interviewed and PC was established for the arrest of the driver for R&C Stolen Vehicle.

Further investigation led to the recovery of a handgun that was in plain view in a vehicle parked next to the recovered stolen vehicle.

Keys to this vehicle were recovered in the stolen vehicle.

Southfield Detectives conducted follow up investigation and PC was established to charge suspect with R&C Motor Vehicle and CCW.

Suspect was arraigned on both charges.

Southfield Police Dispatch advised they received a 911 call from a male who stated he was robbed about ten minutes earlier from a friend.

The caller stated he was robbed of an undisclosed amount of cash and his cellphone. Officers were advised the suspect(s) left in a Silver Charger in an unknown direction.

Soon after this Dispatch advised the male called back and stated he was not robbed, however, he was trying to figure out where he was and looking for a ride back home.

While Officers were on their way to location Dispatch advised the male called back again and was now stating the suspects returned and he was currently being robbed again.

Officers arrived on scene and met with victim.

The victim confirmed that he was robbed by three of his friends. He refused to identify the suspects and stated he needed a ride to Detroit. Officers continued to question victim about the Robbery and subject was uncooperative. He continued to ask for a ride to Detroit. Officers advised subject not to call 911 anymore and called back into service. The subject continued to call 911 several times after Officers cleared. Officers returned to the Bus Stop located subject and took him into custody for Misuse of 911 System. The subject was also charged with Obstruction for giving false information about his identity.

#### **Domestic Assault/ Shots Fired**

#### (Apartments)

Victim (male) came into the front desk and advised on June 22, 2020 around 8:00pm he was at a friend's house to get some food when his friends boyfriend arrived. The boyfriend instantly became aggressive thinking victim was there for more than just to have something to eat.

Victim stated he walked outside to avoid confrontation but the subject followed him outside. Victim got into his vehicle to leave and suspect fired 4 shots in his direction from a handgun.

Victim was not injured.

Victim states since the incident suspect has been riding around the complex looking for him. Suspect has been identified and incident is under investigation.

#### Domestic Assault/ CCW- 1- Arrest

#### (Hotel)

Male and female victim got into an argument because the male half thought the female half was texting another male.

Victim states the male half threw a bottle of liquor on the floor and pushed her down onto the hotel bed. He then got on top of her and punched her to the left side of her face.

On 06/28/2020 at approx. 1:50am, Officer was stationary writing a report when he heard squealing tires and observed a Dark Color Dodge Charger racing, N/B on Greenfield Rd approaching Providence Drive. Just as this occurred a citizen advised Officer the subjects in the Dodge Charger had just pulled handguns and rifles on everyone in their vehicle at the gas station at Nine Mile Rd. and Greenfield Rd. Officers conducted a traffic stop on the vehicle, Dodge Charger. This vehicle came to a stop at the entrance to Apartment Complex on Providence Drive. Both occupants of the vehicle were immediately compliant. The driver made admissions that there were several firearms in the vehicle. Both subjects were removed from the vehicle and detained while Officers conducted their investigation. It should be noted that at the time of the traffic stop, both the driver and the passenger were wearing purple colored latex gloves and both matched the description of the suspects.

Officers observed a handgun, with an extended magazine sitting beneath the driver's seat and a Black, AR-15 rifle sitting in the rear seat directly behind the driver's seat.

A Southfield Police Evidence Technician photographed the vehicle and the firearms prior to collecting as evidence.

Both occupants of the vehicle did not have valid CPL's.

The handgun came back as a stolen out of Southfield PD.

Both subjects were taken into custody for CCW & R&C Stolen Property. Oak Park Officers responded to the traffic stop and were advised on the Felonious Assault which occurred in their city at W Nine Mile Rd. and Greenfield Rd.
