



Several Officers responded to a report of a male shot in the foot in the parking lot at Hotel in the 15000 Block of Town Ctr. Southfield Dispatch received a call from a subject claiming to have been shot. Hotel security called as well and advised that they heard a shot and had a male on the ground. The victim was located with a GSW through the right foot and advised he was robbed. A vehicle returning to the Hotel at a high rate of speed was stopped by officers. The officers identified the female driver as the shooter. The investigation revealed that the two had a domestic violence incident and were fighting over the female's purse. The weapon was recovered and the female made a statement. The male was uncooperative and was taken to Providence Hospital for medical treatment. He kept saying that he was robbed by someone.

The female was interviewed by Detectives. Victim told Detectives that the male subject was her boyfriend. He was upset with her because she was talking to another male. He assaulted her numerous times out in the parking lot of the Hotel and then dumped out her purse. Her handgun fell to the ground, he grabbed the gun, pointed it at her and threatened to kill her. He then dropped the gun and walked away. The female was grabbing her handgun and her belongings when the male subject ran up on her once again with his fists balled up. Victim feared for her life and she started to run away from him. While she was running, she

On 03/15/2021, at approx. 3:33am, Several Officers responded to residence located in the 29000 Block of Lancaster Dr. (Apartment Complex) on report of a stabbing that had just occurred. The R/P was the female half of a Domestic Assault and she made admissions to Southfield Police Dispatch that she stabbed the male half. Further information from R/P prior to Officers arrival was she was holding her 1-year old child when the male half was punching her in the face.

Officers arrived on scene and found the door to apartment open and observed an extensive amount of blood inside the apartment. Officers located both parties and began treating the male victim until Southfield FD Life Support Unit arrived on scene.

The male was transported to the hospital where he was pronounced deceased. The female half was taken into custody for Homicide and the Investigation is on-going.
