


## **Special Attention: Shooting Investigation**

### Greenfield Rd. & J L Hudson Dr. (Bus Stop)

Officers responded to Hospital in the 16000 Block of 9 Mile Rd. reference a gunshot victim that claimed he was shot near the bus shelter. Officers found signs of fresh blood near the bus stop on JL Hudson Dr. No spent shell casings or spent rounds were recovered. Victim stated he got off the bus and heard gunshots but did not realize he was hit. Victim claims that several persons from the bus scattered after hearing the gunshots. (Nobody reported incident.)

A short time later victim observed blood in his boot so he went to the hospital to get it checked out.

so he went to the hospital to get it checked out. It was determined that victim suffered a Gun Shot Wound to his left shin that exited out his left calf. The injury was not life threatening.

**Subject:** News Release

On January 23, 2020 at approximately 7:30 p.m., an armed robbery occurred at Party Store located in the 19000 Block of W. 10 Mile Rd. The suspect entered the store and demanded that the employee put money inside a bag or he would shoot. The employee dove behind the counter at which point the suspect began to flee the store. While fleeing, the suspect fired a shot at the clerk. Once outside, the suspect fired a second shot toward the front door. The clerk was not injured.

The suspect is described as a black male, possibly 20-30 years old, wearing a blue hooded sweatshirt and dark jeans. The suspect has a tattoo on his right hand.

Crime Stoppers is offering a \$1,000.00 reward if credible information is received that leads to the apprehension of the suspect. Officers were driving south on Greenfield Rd, south of Nine Mile Rd when they observed a Chevy Cobalt with a temporary license plate. After running the plate in LEIN, it came back no record. Officers initiated a traffic stop on the vehicle and contacted the driver. After asking the driver for her license, registration & proof of insurance the driver responded that her license was suspended and her license plate was cancelled.

Officers confirmed that the female's driver's license was suspended and the last license plate for vehicle was cancelled in 2018.

The driver was taken into custody for DWLS. During the search incident to the arrest of suspect vehicle Officers recovered a Taser in a black case on top of the passenger seat. Officers tested the Taser and it was functional. The driver did not have a CPL. The driver was also charged with CCW.

### (High School)

On 03/03/2020 at approx. 9:10am Southfield Police Resource Officer was notified via school radio that a teacher needed assistance with a student in her classroom. It was later learned that the student was causing a disturbance in the hallway, threatened and assaulted a teacher. The student was located and escorted to the main office. A second Liaison Officer also made the school to assist the other Officer.

When the original Officer on scene went to speak with the teacher the student became upset because Administration was going to suspend the student. The student started swearing at administrators causing a School Disturbance and attempted to leave the office. He physically knocked one of the administrators out of the way to flee the office. The second Officer, now on scene intervened and attempted to stop the student. The student stated, "I'm not afraid of the Police" and attempted to assault to wit "punch" Officer with his fist.

Officer attempted to secure the student and was injured during this exchange to wit his wrist was cut and bleeding when attempting to hand cuff the student.

The first Officer on scene returned to the Office and Officers took the student into custody for A&B Police Officer, A&B on two faculty/administrators and Disorderly Conduct.

A Southfield Police Evidence Technician took photos of Officers injury. The student was taken to Children's Village and his parents were notified.



#### **Possession of Crack Cocaine-**

Officers were on routine patrol when they conducted a Lein Check on a Gray Cadillac CTS. The plate returned 'no record on computer'. After stopping the vehicle. There were two occupants in the vehicle. During Officers investigation, it was discovered that the female passenger had stuffed a crack pipe and a small bottle down the front of her pants. Officers also observed suspected white powder associated with the passenger's wallet which she had placed on the dash of the vehicle. Further investigation by Officers led to the recovery of suspected cocaine inside the wallet.

The suspected powder was Field Tested by a Southfield Police Evidence Technician and the result was positive for possible presence of Cocaine. The passenger was taken into custody for Possession of Cocaine.

Some tax scams involve unexpected refunds that are deposited into personal bank accounts. Scammers then impersonate IRS agents, alter the Caller ID information and contact the refund recipient advising them the money must be returned before facing arrest, deportation or suspension of their driver's license. The target will be asked to return the refund through a gift card or wire transfer or the caller will attempt to get personal information from their target.

# Citizen's Beware- The IRS will not do the following:

• Call to demand immediate payment using a specific payment method such as a prepaid debit card, gift card or wire transfer. Generally, the IRS will first mail

# CCW/ Felonious Assault w/ a Firearm-

1- Arrest

#### (Commercial- Café)

Officer was at business placing an order when he observed two subjects & vehicles in the drive thru that appeared to have been involved in an accident.

When Officer went outside to investigate the two subjects were exchanging words and one of the subjects stated, "What's up" lifted his left arm up from his left side, exposing a black handgun inside of a black holster.

Officer immediately identified himself and drew his department issued weapon and ordered subject to drop his weapon. The subject immediately complied and placed the handgun on the front driver's seat of his vehicle. Officer conducted a pat down of subject, radioed for assistance and secured subjects handgun.

Additional Officers arrived and all parties involved were interviewed, including employees from business.

Victim stated that he was in the drive thru and after receiving his order he tried to exit but suspect's vehicle was blocking him. Victim sounded his horn and suspect wouldn't move up to let him out. Victim then began yelling out his window for suspect to move up. At this point the suspect exited his vehicle and threatened victim, he reached into his pocket and told victim he could take his life. Victim didn't see what the suspect had in his hand but he felt threatened.

Officers questioned the suspect and asked him if he had a CPL. The suspect stated no. The suspect was taken into custody for CCW & Felonious Assault with a Firearm.

When using an online tax preparation service, look for the tax preparer identification number. The IRS requires all paid tax preparers to have one before filing any returns.

Officer stopped a vehicle for several traffic violations.

After contact was made with the driver, the driver refused to roll his window down and only cracked it.

Officer advised the driver why he stopped him and asked him for his license, registration and proof of insurance. The driver refused to provide any information. The driver asked why he was stopped. After explaining the reason for the stop again, the driver still refused to provide his driver's license, registration and proof of insurance and rolled his window up all the way.

A LEIN check revealed that the subject had a suspended driver's license and outstanding warrants out of Macomb County and Livonia. There was a woman standing in the driveway of the residence. Officer asked her if she knew the individual driving the vehicle.

She advised it was her boyfriend and she attempted to reason with him and told him to provide his ID to Officers. He still refused to identify himself.

The driver was taken into custody for DWLS & Resisting & Obstructing. It was discovered that the driver had a Suspended Driver's License with 14 Suspensions and 2 Prior Convictions.
