


Dispatch advised they received alarms triggering counter motion, hallway motion and dining room motion. Upon arrival Officers discovered the North glass door had been broken into. It appeared the suspect(s) used a prying device to make a small hole in the glass just above the lock. The suspect(s) then reached in and unlocked the glass door to gain entry. Officers made entry and cleared the business, suspects were GOA. The cash drawer from the drive- thru appeared to be missing. The manager arrived on scene and stated the only thing missing is the cash drawer from the drive-thru. There was no money in the drawer and nothing else was taken. Surveillance video from the store shows a male suspect pulling into the parking lot in a White Lincoln Town Car type vehicle. The vehicle had two strips of duct tape on the driver's side window. The unknown male is described as 5'-10", approx. 225lbs. He was wearing a black skull hat, facemask, brown Carhart Jacket, black hoodie, and blue pants. The male exits the vehicle and walks over to the north Glass door. He can be seen prying/braking a hole into the glass door to make entry. Inside the store, he goes to the drive-thru window and removes the cash

Surveillance video shows unknown male wearing a face mask, knit hat, blue jeans, red work gloves and a light brown work coat smash the rear door and enter the business at 4:29am. The suspect proceeded directly to the counter, jumped the counter, ripped out the cash drawer, jumped back over the counter with the drawer and fled the scene. A Southfield Police Evidence Technician processed the scene.

Special Attention: MDOP/ Domestic Assault/ Larceny of Handgun

03/14/2021 12:50am

27000 Block of Franklin Rd.

(Apartments)

On 03/14/2021 Officers were dispatched to the 27000 Block of Franklin Rd. regarding a Domestic Assault. Security was out with the female resident who had been assaulted by her boyfriend. The boyfriend fled the area in a 2007 Blue Chevrolet Impala. Officers arrived on scene and observed victim's

Officers arrived on scene and observed victim's apartment door frame damaged and the door appeared to be broken.

Officers met with the female victim who had a swollen face and a broken fingernail that was bleeding. There was also numerous items broken throughout the apartment and the female's cellphone was damaged and appeared to be bent.

Victim states her part time boyfriend found something on her phone and was upset. He vandalized her apartment and broke several items. At one point during the assault on victim he

threatened to kill her and began choking her.

The male suspect fled the apartment prior to the police arriving.

R/P advises after the suspect left she realized that he took her handgun that was on the kitchen table. A Southfield Police Evidence Technician processed the scene and took photos of victim's injuries.

Officers were on routine patrol when they observed vehicle driving w/o its headlights on. The vehicle was stopped and contact was made with the driver and female passenger.

Further investigation by Officers led to the recovery of suspected crack cocaine and paraphernalia associated with the narcotics.

A Southfield Police Evidence Technician Field Tested a sample of the suspected crack cocaine and it tested positive for possible presence of cocaine.

Both the driver and female passenger were taken into custody for Possession of Crack Cocaine and Narcotics Paraphernalia. The driver was also charged with DWLS & a Southfield Warrant for Disorderly Person.

23000 Block of Telegraph Rd. (Hotel)

Officers were dispatched to the 23000 Block of Telegraph Rd. (Hotel) for a possible Drug Overdose. Call initially was reported as a medical run and the Southfield Fire Department was dispatched regarding the passenger of a Black Dodge Avenger who was passed out and not responding.

The female subject was with a male who was questioned. She was in the passenger seat of the male subject's vehicle when he discovered she was unconscious and not responding to him. The male was staying at the hotel. He gave Officers verbal consent to search his vehicle and room. No drug paraphernalia, narcotics, or suspicious substances were found in either the vehicle or the subjects room. The female subject was pronounced deceased at 19:51 hours. The cause of death is unknown and there were no signs of trauma to the body. Officers noted that there was possibly scarring from needle punctures on the inside of both the victim's forearms. There were no obvious recent needle punctures other than IV punctures from paramedics. DB was notified and Investigation is on-going.

On 03/11/2021 at approx. 1:29am, Officers were dispatched to the 26000 Block of American Dr. (Hotel) for a noise complaint. The caller advised dispatch a black vehicle was playing loud music in the parking lot near the entrance.

Upon arrival, Officers observed a Black Ford Fiesta near the entrance with loud audible music. Officers began to approach the vehicle. While walking towards the driver's window, Officer noticed the driver had his feet out of the window and was leaned back in the driver's seat. Continuing to approach the vehicle with flashlight directed towards the driver he immediately sat up reacting to the light and aimed a handgun at Officer with his right hand, out of the window. Officer immediately took cover and notified other Officers that the subject was armed with a gun. Officers identified themselves and had the subject at gun point. The subject was ordered to show his hands, he placed both hands out the driver's window. Officers asked where the gun was at and he replied, "I'm sitting on it". The subject was then ordered out of the vehicle. After the suspect was out of the vehicle and secured Officers confiscated the handgun from the front seat of suspect's vehicle. The handgun was a loaded, one in the chamber. The subject did not have a CPL to carry a handgun.

The subject was taken into custody for CCW & F/A on Police Officer. Officers also located a plastic baggie with white residue in suspects coat pocket. There wasn't enough substance for a Field Test. The suspect made admissions that it was cocaine and he had snorted it.

The driver was driving with no willful or wanton regard for the safety of persons or property. Officer maintained a constant visual eye of the vehicle. The vehicle exited n/b Telegraph pulling into the service area of the Car Dealership in the 28000 Block of Telegraph. The driver originally pulled into the service area, then reversed and went to the front of the building. Officer requested additional Officers who responded to the

Officer requested additional Officers who responded to the dealership location. The driver of the vehicle went into the front entrance of the Dealership. Officers were about to enter the dealership when the subject exited the dealership. When they confronted the subject, he was uncooperative, trying to put his hands in his pocket and was trying to avoid Officers to get back to his vehicle. During the confrontation Officer observed a handgun on the passenger seat of suspect's vehicle. The subject realizing Officers seen the handgun fled on foot. Officers pursued the suspect towards the rear of the Dealership. The suspect jumped over the fence to the adjacent Apartment Complex. Officer jumped over the fence and pursued suspect until he stopped running and laid down in the grass. Officer held suspect at bay until other Officers arrived.

A loaded handgun was recovered from the suspect vehicle.

The unknown male is described as 5'-10", approx. 225lbs. He was wearing a black skull hat, facemask, brown Carhart Jacket, black hoodie, and blue pants.

The suspect can be seen prying/braking a hole into the glass door to make entry.

Inside the store, he goes to the drive-thru window and removes the cash drawer and knocks the cash register onto the floor. He then leaves the store, puts the cash drawer in the rear driver's side seat and leaves S/B on Telegraph.

The suspect entered the business at approx. 6:01am. He is seen leaving the business at 6:02am. There was no money in the cash drawer that was taken.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.
- -Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
