


On 05/06/2021 Officers were dispatched to the 27000 Block of Northwestern Hwy (Hotel) for suspicious person walking back and forth from their hotel room out to their vehicle.

Retail Fraud/ Assault/ Armed Assailant

(Commercial Wholesale Business)

Officers were dispatched to the 30000 Block of Southfield Rd. for a report of a Retail Fraud/Felonious Assault at business.

R/P (Loss Prevention for Business) was monitoring the camera system and observed suspect conceal two Amazon Fire TV cubes in his jacket while in the Electronics Department. The R/P began conducting physical surveillance. The suspect headed toward the front of the store and observed R/P conducting surveillance on him. The suspect entered the rug aisle and abandoned one of the Amazon Fire TV Cubes. The suspect continued walking and then stopped and lifted his shirt, revealing a handgun holstered in his right waistband.

R/P immediately disengaged physical surveillance and the suspect exited the store, passing all points of sale and making no attempt to pay for the single concealed Amazon Fire Cube.

The suspect was observed entering the passenger seat of a Silver Ford Focus and left the scene.

R/P was unable to observe the driver or the license plate of the vehicle.

Suspect Description:

R/P described the suspect as a male of unknown race, possibly white or Hispanic, early 30's, Approx. 5'8" and medium build. The suspect was

1- Arrest

15000 Block of W Eleven Mile Rd.

(Apartments)

On 05/09/2021, Officers were dispatched to the 15000 Block of W Eleven Mile Rd. (Apartments) on a suspicious incident. R/P (Uber Driver) is requesting Police because he has a male and female having a domestic dispute in his vehicle.

Upon arrival Officers located the two combatants in front of 15805 Eleven Mile Rd. The female stated that they had been arguing all day and that the male had punched her earlier in the leg. The female had a bruise on her leg. The female also advised that the male subject had some weed on him and some white powdery substance.

The male subject was taken into custody for Domestic Assault and searched incident to the arrest. Officers located a large amount of US Currency in the suspects pocket.

Officers requested permission to search suspects belongings. Officers searched a white and blue duffle bag and pulled out a black Sentry safe which was unlocked. Officers opened the safe locating a sandwich size zip lock bag with four individual bags of suspected crack cocaine. The safe contained a large sum of money. There was also a scale under the safe that was taken as evidence.

The male suspect was taken into custody for Domestic Assault & Possession of Crack Cocaine & Prescription Drugs w/o a Prescription. After being transported to the jail for processing Officers recovered additional suspected Crack Cocaine that was concealed in suspects crotch area.

A Southfield Police Evidence Technician Field Tested a sample of the suspected Cocaine. The result was positive for possible presence of Cocaine. Photos were also taken of victim's injuries.





Domestic Assault/ Resist & Obstruct- 1- Arrest

05/04/2021 6:24am

17000 Block of Goldwin Dr.

Officers were dispatched to the 17000 Block of Goldwin Dr. for a reported Domestic. R/P stated there was a verbal argument between 2 females who had been drinking alcohol and one of the females had a kitchen knife.

Officers arrived on scene and could hear two females screaming at each other. Officers announced themselves and made entry into the residence. The two females were separated and questioned. Investigation revealed the two females were intoxicated and have been in a dating relationship for 5 years. The two got into an argument today and the one females (suspect) assaulted the other. The female that was assaulted had a panic attack while Officers were investigating and a Life support unit was called to the scene to check on her wellbeing. While this was going on the other female (suspect) kept interfering with Officers investigation and tried to push past Officers to get to the other female. She was taken into custody for Domestic A&B and R&O Officers.

Note: The second female (victim) started to make threats that she wanted to kill herself. Officers took her into protective custody, transported her to Providence Hospital and had her committed for mental health evaluation.

Victim (Student) states she was walking back from a job interview in the 25000 Block of Evergreen Rd. to go to her dorm room in the 21000 Block of 10 Mile Rd. She was walking w/b on Ten Mile Rd. next to the football field at her college campus when an unknown B/M approached her. The suspect asked her to come over to the trailers located next to the football field to talk. Victim did not really understand what the suspect was talking about because her English is not very good. Victim went with the suspect behind the trailer. Once they were behind the trailer, the suspect started talking to her inappropriately and touched her inappropriately. Victim ran away from suspect and ran back towards campus. The suspect didn't follow her and victim was not injured by the suspect.

When victim got back to campus she located a Campus Security Person and notified him what happened. Victim advised the suspect was wearing a gray hoodie, was clean shaven, mid 20's, with tattoos on his left arm.

A Southfield Police Evidence Technician met with Security and the victim. He reviewed their surveillance video. The surveillance video shows victim and an unknown light skinned B/M, 18-25 years old, 5'10 to 6' tall, 140lbs to 160lbs wearing a black knit hat, black mask, gray hoodie with a "CT"

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with

Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

-Citizens should always be mindful not to leave anything of value in their vehicles. Especially wallets, purses, cash, handguns, cell phones, laptops, jewelry, or anything else of value. If you must leave your handgun in your vehicle it should be kept in a gun lock box that is bolted down in the trunk of the vehicle. At the very least you should try to hide the handgun somewhere that it would be difficult to find. The first place that criminals will look is under the front seat, in the center console or in the glove box.
