

The business does have an alarm system but there were no activations? Officers arrived on scene and observed the front door pried open (there was yellow paint transfer on the door and frame). Inside the business, the top of the ATM was knocked over, but it did not appear to be accessed. There was an internal door, which led to the back where the narcotics are stored in a safe. This door appeared to be tampered with (pry marks), but entry was not gained. In addition, there was various merchandise scattered throughout the business and knocked off shelves. There are internal cameras in the business that captured the incident. At 4:33am Five (5) unknown males pried open the front door with a crow bar and entered the pharmacy. They moved around the business, attempted to pry the interior door to where the medications are kept. They were unsuccessful. At 4:35am suspects are temporarily scared off by security light and ran out of the business. They returned though and took some purses from the jewelry cabinet, and fled the business. The suspects are described as: 5- unknown males wearing dark clothing, hoodies, face

			masks, hats, and gloves. One male had a large Nike Air emblem on the back of his hoodie. No vehicle description. Suspects had crow bars, at least one of them was yellow.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
