



Special Attention: Larceny from Vehicles How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. CCW/ Fleeing & Eluding/ R&O- 1- Arrest 11/28/2021 7:51pm Northwestern Hwy. & North Park Dr.

Officers were searching the area for suspects in a previous Robbery when they observed a vehicle with three subjects in it. As the officers began to turn their car around the suspects began to accelerate away from Officers. Officers activated emergency equipment and a short pursuit ensued. Officers utilized the PIT maneuver to terminate the pursuit. Three suspects fled from the vehicle. Two suspects were observed dropping hand guns as they fled. The driver of the suspect vehicle was apprehended. The other two suspects fled west and then north into the residential neighborhood.

The front seat passenger was a B/M 18-25 years old, wearing a black jacket, black jeans, and a gray hoodie under the jacket. Second suspect was a B/M, 18-25 years old, wearing dark clothing exited the rear driver side door. Both subjects fled on foot and were not located. Oak Park K-9 tracked for the two suspects and they were not located. A third handgun was located, in the vehicle. The driver who was apprehended was held without bond pending arraignment.

Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

-Citizens should always be mindful not to leave anything of value in their vehicles. Especially wallets, purses, cash, handguns, cell phones, laptops, jewelry, or anything else of value. If you must leave your handgun in your vehicle it should be kept in a gun lock box that is bolted down in the trunk of the vehicle. At the very least you should try to hide the handgun somewhere that it would be difficult to find. The first place that criminals will look is under the front seat, in the center console or in the glove box.

Synthetic Narcotic Manufacturing/ Traffic Complaint-1- Arrest

Officer observed Traffic Violation at 8 Mile Rd. & Northland Dr. After stopping the vehicle Officer observed the driver and female passenger switch seats. Both occupants were identified and the driver, now seated in the passenger seat came back with several traffic warrants out of other jurisdictions. There was also a felony warrant for Possession of Cocaine that was confirmed.

Additional Officers arrived to assist. There was furtive movement in the vehicle by the suspect that had changed seats. Officers contacted this subject and he was taken into custody w/o incident.

Further investigation, the suspect had a large sum of money on his person. There was also a large amount of money, marijuana, packaging materials, scales and unknown pills discovered in the vehicle. The bottles were not labeled for sale or prescription. All cash, marijuana, narcotics, and narcotic paraphernalia were confiscated and placed into evidence. A Southfield Police Evidence Technician processed the scene and collected evidence.

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Officer was on routine patrol when he observed vehicle turn S/B onto N/B Northwestern Service Drive.
