



The suspects used a large brick to break the south window out on the Cell Phone Store. Witness observed the subjects leave in a Black Jeep Cherokee with tinted windows S/B on Southfield Rd. Numerous Cell Phones were taken in this B&E. <b>Note:</b> After putting out a BOL of our incident, Northville Township Police advised that one of their Officer's observed a vehicle that matched the description of our suspect's vehicle at a Cell Phone Store in their city. The Officer attempted to initiate a traffic stop on the vehicle and the vehicle fled from him.
