


Officers arrived on scene and located the victim. The victim stated that himself and his brother got into an argument about something that happened a couple months ago. At some point during the argument victims brother punched him in the face a couple times and then pulled out a handgun from his pocket and cocked it. At this point, other family members and friends intervened and broke it up. Victim stated the gun was never pointed at him but his brother threatened to kill him after the gun was pulled out.

Note: Video surveillance from the Gas Station confirmed incident and showed suspect pulling out a handgun. Suspect has been identified and incident is under investigation.

On 12/06/2020, Officers were dispatched to the 26000 Block of American Dr. (Hotel) on a report of an assault. The caller stated there was an Asian female in the front lobby with blood on her hands and neck, as well as bruises on her eyes. The desk clerk called police after someone called the front desk six different times attempting contact victim in her room.

Upon arrival Officers contacted the victim, she had been beaten and tied up. Paramedics were called to the scene and the victim was transported to the hospital for treatment.

Officers went to victim's room to conduct a welfare check using the key card provided by victim.

Upon entering room officers immediately noticed blood stains throughout the room. The room was completely disheveled and there was obvious signs of a struggle and assault. The room was cleared and no one was found in the room. Officers observed blood throughout the room including a bloody knife and several bloodied Zip Ties. (Similar to another incident that recently occurred at another hotel in Southfield.)

It was reported that several males went to victim's room throughout the day.

Officers secured the room pending Search Warrant.

Officers arrived on scene and found the front door of that address open. The residence was cleared with no one inside. There was a spent shell casing found inside and outside the apartment. There were also two bullet holes discovered inside the condo. One in the living room wall and one in the front screen of a TV.

Officers canvassed the area to make sure there were no bullets that went outside the condo. None were located.
