



Victim is unsure if anything was taken. No suspect information.

R/P advises at 9:45am someone rang the front doorbell several times, and then tried to force open the front door. There was damage to the door. The suspect was scared off when the alarm went off. Suspect has been identified and incident is under investigation.

Victim states she left her residence at 2:00pm and when she returned at 3:00pm she discovered the lock on her back door was damaged preventing her from getting into her house. Victim states she thinks she knows who is responsible for the break-in. R/P has had numerous issues with the suspect and he has made other threats in the past to the victim. Victim did not see the suspect near her house when she returned but the suspect rides up and down the street and yells at her when she is out. The person that victim believes is responsible has been identified and incident is under investigation.

It doesn't appear that entry was gained. Nothing was disturbed inside the residence. No suspect information. Both incidents occurred sometime between 6:15am-7:00pm. The deadbolt locks were attacked on both incidents. A 50" Flat Screen TV was taken in one of the incidents. The second incident entry wasn't gained into the apartment.

Possible Suspect information:

Information provided to Officers, there has been a B/M, heavier set walking with a limp in the building. The male is unknown to either of the victims of Home Invasions. Nothing further.

(Apartments)

On 11/05/2019 at 3:06pm, Officers were dispatched to the 25000 block of Shiawassee Rd. to a disturbance. A witness reported observing two black males arguing in the parking lot. One of the subjects in the altercation struck a vehicle in the parking lot. The call between dispatch and the reporting party was then disconnected.

Officers arrived on scene and observed two black males walking away from the apartment building to a vehicle in the parking lot. Both subjects were stopped and interviewed. Information was gathered from the two brothers that their mother's boyfriend had made threatening phone calls to one of the brothers. He was concerned because his two children were being watched by his mother. When victim showed up to get his kids, the mother's boyfriend produced a handgun and threatened bodily harm on him. (The two parties apparently don't get along.)

As Officers were interviewing the two brothers the suspect came out onto the balcony of the apartment and started yelling at the two brothers. The subject was advised by Officers to return to the apartment and stop yelling. The suspect came out onto the balcony several more times and continued to yell at the brothers and cause a disturbance.

Officers went into the apartment building and attempted contact with suspect yelling from the balcony and to speak with the victim's mother. There was no response at the door.

As Officers were getting ready to leave, the victim's mother came running out to Officers and advised that her boyfriend (suspect

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive. yelling from balcony) had a gun and threatened to kill her after the police left. As soon as she had the opportunity, she fled apartment. Victim gave Officers permission to enter her apartment and gave them her keys to the apartment. When Officers attempted to open the door to victim's apartment the suspect barricaded himself in the apartment and it was believed that he was armed. Officers backed away from the apartment, set up a perimeter around the apartment, secured the area and called in the Southfield Police Special Entry & Response Team. (SERT Team) Contact was made with the suspect and he refused to come out of the apartment peacefully.

The SERT Team arrived a short time later and made entry into the apartment. The suspect was located and taken into custody w/o incident. A handgun was located and confiscated inside the apartment. The serial # on the handgun had been altered. The suspect was arrested for F/A Domestic/ Felon in Possession of a Firearm/ Possession of Firearm with Altered Serial#. No injuries were reported during this incident.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

Special Attention:

Larceny of Packages that were ordered and delivered via Common Carrier.

How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages.

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

OWI/ A&B on Hospital Staff 1- Arrest 11/04/2019 12:54am 10 Mile Rd./ Berg Rd.

Officers responded on a slumped subject with the subject's daughter on scene. The operator of the vehicle was found to be intoxicated and combative with Officers and family members. She was arrested for OWI. While at the hospital for a blood draw the suspect was being verbally aggressive towards hospital staff. She was yelling and using profanity and racial slurs towards staff and security. She refused any treatment from hospital staff and refused to give her vitals. She continued to yell racial slurs at Officers and hospital staff. The suspect then kneed a nurse in the face while she was attempting to get a blood sample. When business was completed at the hospital and the suspect was cleared she was taken to Southfield Jail charged with OWI & A&B on Hospital Staff.
