

The plate came back stolen out of Detroit. The driver had no paper work or bill of sale for the vehicle and disallowed any knowledge of the stolen dealer plate.

The vehicle appears to be a re-tag and was impounded. An inventory search of the vehicle Officers found a handgun in the driver's backpack. He made admissions that the handgun belonged to his sister (confirmed) and he stated he didn't have a CPL.

The driver was taken into custody for R&C Motor Vehicle and CCW. During the search of suspect Officers recovered a red key for a Jeep Track Hawk. It was not the correct type key for the recovered stolen vehicle but it worked for the Dodge Durango SRT?

Follow Up Investigation by Detectives:

The federal sticker on the inside of the driver door appeared to be tampered with. The VIN on the dashboard also did not match the VIN on the federal sticker. The hidden VIN on the 2020 Dodge Durango was located and came back to a stolen Dodge Durango out of Sterling Heights on

#### 20000 Block of Mada

Officers were working as a double unit and were dispatched to the 20000 Block of Mada Ave. on 11/14/2020 at 2:00am for a reported suspicious circumstance. An unknown suspect fired 4 shots into a Blue, 2013, Dodge Charger. The vehicle was unoccupied at the time of the incident. No injuries.

R/P states he heard gunshots at approx. 1:39am.
R/P and his roommate went outside and didn't observed anything unusual. R/P reviewed the Ring Doorbell camera footage and observed an unknown Black SUV driving W/B Mada, slow down in the 20000 Block of Mada and shot approx. four shots towards vehicle.

Southfield Dispatch received numerous calls reference several shots being fired near Berg Rd. & 9 Mile Rd. One witness that was interviewed stated a "supped up" Burgundy Dodge and an unknown black car were involved in shooting on S/B Berg just north of Nine Mile. The burgundy vehicle was the one shooting at the other with an AK-47 type gun.

Surrounding area and local hospitals checked negative for any victims. The vehicles and subjects were not located.

#### **Suspects:**

The passenger of Burgundy Dodge was a light comp. black male wearing a beige sweater and khaki pants. Southfield Police Evidence Technicians responded to the scene and recovered several spent shell casings and other evidence.

Officers attempted to stop a Jeep Grand Cherokee SRT that committed multiple traffic offenses. The Ohio Plate on the vehicle was improper and came back on a Kia.

Officer attempted to stop the vehicle. He activated his emergency lights. The vehicle turned east into a lot and went over a small curb to avoid Officer. The Jeep Disregarded Officers emergency lights/sirens and attempted to pull back out onto W 8 Mile Rd. The Jeep attempted to accelerate and flee but got caught in heavy traffic.
