(Commercial- Food) On 10/19/2021, Officers were dispatched to business in the 24000 Block of W. Ten Mile Rd for a trouble with subject. The R/P's son was at the business begging for money. Upon arrival, Officers contacted the R/P and his son. R/P's son was highly agitated and uncooperative with officers. Information was gathered that the R/P's son requested money, his birth certificate and his SS Card from his father. When the father told his son, he didn't have any of the items and refused to give his son money he became disorderly and refused to leave the area. Suspect was warned several times and was offered a ride which was refused. The suspect continued to be disorderly, disturbing businesses in the area.
