


10/20/2020 3:56pm 28000 Block of Franklin River Dr.

(Apartments)

Officers were dispatched to the 28000 Block of Franklin River Dr. regarding a disturbance. Dispatch stated there was a B/M chasing a B/F, into the woods in the back of the complex. Witnesses stated that the two were fighting over a handgun.

The female left the scene as Officers were arriving. The male was located and interviewed. The male stated they he and his girlfriend got into a verbal argument that escalated to where it became physical. The male half told Officers that the female had a handgun in her purse and he was concerned she was going to get it out because she has taken it out in the past and threatened him with it. The male took her purse and ran into the woods

adjacent to apartments. Male states female tried to run him over with her car before he reached the

woods. (There was evidence of a vehicle jumping the

curb and going into the grass)

The female ran into the woods after male. Male states he removed the magazine and chambered round from her handgun and threw the purse back to her (with the handgun). The male continued to run from the female until he met with Officers in the

Investigation revealed that the two got into a verbal argument and the male half attempted to take her keys and cell phone. The dispute escalated and became physical between the two. At some point the female half got a knife from the kitchen and threatened the male half with it. After getting her keys and cell phone, the female put the knife down. The male half grabbed the knife and hid it in his bedroom. The female half was taken into custody for Domestic Assault.

Providence Dr. & W Nine Mile Rd.

On 10/24/2020, at approx. 4:14am, Officers were dispatched to the area of Providence Dr. & Nine Mile Rd. to conduct an area check for a child running naked in the area. Dispatch advised that the caller is known, she has a history of calling stating there is a child or adult running naked in the area.

Officers located the suspect and spoke to her about only calling 911 for emergencies. The caller insisted that every time she has called she sees a child or man running naked?

This is the fifth time that this person has called reporting this type of activity. On every call Officers found the calls to be unfounded.

It appears that the subject may be mentally challenged. Officers questioned her if she needed any help and she stated she didn't want to hurt herself or others.

Note: Suspect has a history and has been arrested in the past in another jurisdiction for Harassing Calls to their Telecommunications.

The suspect was released at the scene and advised not to call 911 unless it's an emergency.

Officers (Double Unit) were on patrol near Telegraph and Eight Mile Rd. They observed a B/M riding a bicycle on the sidewalk N/B on Telegraph Rd.
